KMCH achieves new milestone in treatment of irregular heartbeat Coimbatore

Coimbatore, Apr. 3: Kovai Medical Center and Hospital (KMCH) has achieved a new milestone in the treatment of irregular heartbeat (Atrial Fibrillation) by successfully performing 50 advanced Cryoablation procedures. With this achievement, KMCH has become one of the top six hospitals in India to have performed the highest number of such procedures.

It has also earned the distinction of being the only hospital outside Chennai in Tamil Nadu to have carried out this treatment in such significant numbers. Doctors explained that Atrial Fibrillation increases the risk of blood clot formation and raises the chances of stroke by three to five times. The advanced 'Cryoballoon' technology is used as an effective treatment method for this condition.

In this minimally invasive procedure, a balloon-like device is inserted into the heart through a small puncture in the thigh, without open surgery. Nitrous oxide gas is used to create intense cold, which freezes and neutralises the tissues



responsible for irregular electrical impulses, thereby restoring a normal heart rhythm. The hospital's specialised centre also offers comprehensive care, including personalised treatment plans for high blood pressure, obesity, and sleep disorders.

Additional services such as heart rhythm monitoring through mobile applications and teleconsultation via video calls are also provided. Chairman and Managing Director Nalla G. Palaniswami stated that reaching the 50th Cryoablation milestone reflects the hospital's commitment to delivering world-class medical technology to

patients. "Since our inception in 1990, our goal has been to provide international-standard healthcare," he said. Managing Director Arun Palaniswami noted that the milestone represents not just a number but an improvement in the quality of life for 50 patients.

He affirmed that the hospital would continue to make such advanced treatments accessible to patients across Tamil Nadu. Cardiologist Dr. Lawrence Jesuraj described Cryoablation as a safe and highly effective treatment for Atrial Fibrillation.

Strict action against illegal LPG sales: Collector

Dharmapuri, Apr 3: Dharmapuri District Collector R. Sathesh has warned that hoarding of LPG cylinders or selling them at higher prices is a serious offence and strict action will be taken under the Goondas Act against those involved in such illegal activities. The warning was issued during a consultative meeting held at the Kurinji Hall of the District Collectorate, organised by the District Supply and Consumer Protection Office to ensure uninterrupted availability of LPG cylinders.

The meeting was held on April 1 under the chairmanship of the Collector. Speaking at the meeting, the Collector stated that there is adequate stock of domestic LPG cylinders in the district and the public need not panic.

Commercial LPG cylinders required for government and private hospitals, government school and college hostels, and breakfast centres are being supplied without shortage. He further said that the supply of commercial cylinders to hotels and business establishments has been increased to 70 per cent by oil companies. Accordingly, from April 3, distribution will be carried out at the enhanced level.



The Collector reiterated that hoarding LPG cylinders and selling them at inflated prices is a grave offence. If complaints are received regarding delivery staff or distributors collecting extra charges, strict action will be taken against them. The public can lodge complaints by contacting 04342-233299 or 94450 00216. He assured that the district administration has taken all precautionary measures to ensure that LPG cylinders are available without shortage to both the public and commercial

establishments. The meeting was attended by District Revenue Officer R. Kavitha, District Supply and Consumer Protection Officer P.K. Govindan, District Food Safety Designated Officer Kailash Kumar, the Collector's Personal Assistant (Nutrition) Sumathi, Integrated Child Development Project Officer Pavithra, officials from Indian Oil Corporation, hotel owners, and representatives of commercial establishments.

23-year-old student collapses, dies during trek to Vellingiri

Coimbatore, Apr. 3: A 23-year-old youth died of chest pain while climbing the Vellingiri Hills to visit the Poondi Vellingiri Andavar Temple near Coimbatore, in a shocking incident.

The deceased was identified as Mukesh Kumar (23), son of Suresh,

from Perumal Koil Street, Peedamneri, in Dharmapuri district.

He was pursuing his fifth year of Pharm D at a private college in Telungupalayam near Perur, Coimbatore, and was reportedly staying in a rented house near the college.

On Wednesday night around 10 p.m., Mukesh Kumar, along with eight friends including Abi and Mahendran,

began trekking up the Vellingiri Hills to visit the temple.

At around 2 a.m., after reaching the fifth hill, he reportedly experienced

sudden chest pain. He collapsed and died on the spot.

Upon receiving information, locals and volunteers carried his body down the hill with the help of stretcher-bearers.

Police have registered a case and are investigating the incident.
