The Notice of Postal Ballot dated November 12, 2024 along with the statement under Section 102 of the Companies Act, 2013 setting out all material facts in respect of the resolutions mentioned therein was sent electronically by email to the members whose names appear in the register of members/ list of beneficial owners as received from National Securities Depository Limited (NSDL) and Central Depository Services (India) Limited (CDSL) as on 20.12.2024 in compliance with the above referred MCA Circulars.
2. The Notice of postal ballot was sent by email to all the members as on 26.12.2024 and whose email addresses are registered with the Company/Depositories, to vote on the proposed 1 (One) Resolution as mentioned in the Notice of the Meeting of M/s. Salona Cotspin Limited (Item No.1 (One)) 12.11.2024. The Members holding equity shares as on the cut-off date i.e. 20.12.2024 were considered for e-voting. Number of shareholders as on cut-off date is 2,439.


