**Sub: Intimation under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 - Temporary Closure of Power Plant, Kiln and Furnaces at Manufacturing Unit, Sarora, Tilda, Raipur.**

Pursuant to Regulation 30 and other applicable provisions of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, we hereby inform the Stock Exchanges that the Company has planned a temporary closure of certain facilities at its manufacturing unit located at Sarora, Tilda, Raipur, on account of scheduled maintenance activities, which will include closure of 15 MW out of the total 25 MW Power Plant, kiln capacity of 300 TPD out of the total 800 TPD capacity, and 3 furnaces out of the total 9 furnaces.

The planned maintenance will be carried out from May 1, 2026 to May 15, 2026 (estimated period of 15 days). During this period, the aforesaid facilities at the Sarora, Tilda, Raipur unit will remain temporarily non-operational.

The Company is undertaking planned maintenance as part of its normal operational activities, with the objective of enhancing efficiency and ensuring the long-term sustainability of its operations. This maintenance is temporary in nature, and the Company has made adequate arrangements, including maintaining sufficient inventory, to meet its operational requirements during this period.
