On December 15, 2023 we received an Email- from the office of Ms. Reena Raphel regarding violation under Regulation 33 of SEBI LODR and imposed the fine of Rs. 47200 (40000 as fined and 7200 as GST)

On December 14, 2023 we have received the letter from NSE for the violation of Same regulation and they imposed Fine of Rs. 171,100 ( 145000 as fine and Rs. 26100 as GST) .
