# SC orders pan-India CBI probe into digital arrest scam cases

### States To Give Consent For Investigation

New Delhi: Supreme Court on Monday ordered a pan-lindia pro-selly CBs into diagnost of the CBs in the CBs

A bench of CJI Surya Kant and Justice Joynanya Bagethi also ordered Uttar Pradesh, Maharashtra, Bi-har, Meghalaya, Madhya Pra-desh, Rajasthan, Tripura and Uttarakhand to "accord san-tice under Seef of the Debt Uttarakhandto "accord sanc-tion under Sec 6 of the Delbi Special Police Establishment (ISPEC) Act to enable CBI to investigate cybor-crime ca-ses" in their territories so that comprehensive action can be taken against digital scam perpetrators who dupe people, especially the edera-Keeping two other forms



vestigate digital arrest scan cases, and the court will con-sider whether the other two forms of cyber-crime require court supervision/monito-ring. Suspecting assistance to scamsters by banking sys-stem insiders, the bench said. "CBI shall have a free hand to "CBI shall have a free hand to investigate bankers under Prevention of Corruption Act when they are suspected to be involved in the opening of 'mule accounts' where the fraudsters park their extor-ted monies."

CJI Kant and Justice Bag CJI Kant and Justice Bag-chi said that given the magni-tude of the crimes and the fact that many of them were being committed from 'scam nubs' located in foreign co-untries, 'we direct the CBI to coordinate with Interpol to lay their hands on the cyber-crim havens operating from abroad.'
