Tragedy in Delhi Cantt: Thar hits motorcycle, couple killed

Their daily ride home from work ended in tragedy on Wednesday when a couple working in the NDMC was killed after their motorcycle was allegedly hit from behind by a Thar in Delhi Cantonment, leaving behind a grieving family.

Anju, around 50, and her husband Sukhbir, around 45, were returning to their home in Sector 1, Dwarka, from their workplace in Lodhi Road when the accident occurred near the IOC red light around 5 pm on Wednesday, police said.

The couple, who had been working together at the New Delhi Municipal Council (NDMC) since 2002 and trav-

elled together daily, were on their way home when their motorcycle allegedly slipped on the road before the SUV came from behind and ran over them, police said.

A staff member of the Delhi Cantonment police station, who was returning from duty, noticed the accident and informed the police. The injured couple was rushed to a hospital, where they were declared dead, police added.

The incident has left the couple's families devastated, particularly Sukhbir's siblings, who said he had recently built a new home and was living happily with Anju, who had entered into her second marriage with him a few years ago.

"I received a call from my

family that an accident had happened. I called his phone multiple times, but it was answered by a police officer. He asked me who I am; I informed him, and he asked me to come to the police station immediately," Chotelal, Sukhbir's younger brother, said.

Chotelal said he went to the police station along with his nephew and was later taken to Deen Dayal Upadhyay Hospital, where they were asked to identify Sukhbir's body. "His jaw was completely broken, and he had injuries on his body. As far as we know, a Thar hit them. They were turning right when the car came speeding from the left," he said. "They have been



working since 2002 and used to travel together daily," Chotelal added.

Anju's son Rohit said the family was informed about the accident around 5 pm.

Police said the Thar driver was caught by locals and handed over to them. The driver was identified as Bhupendra, 26, a resident of Jhajjar in Haryana, they said.

Bhupendra, who runs a milk booth in Rohini, has been booked under sections 281 (rash driving) and 106(a) (causing death by negligence) of the Bharatiya Nyaya Sanhita, police said.

For Sukhbir's family, the accident has also brought back memories of a difficult childhood and the sacrifices made by his sisters to raise him and his siblings after their parents died early.

Ramesh Pal Singh, 65, Sukhbir's brother-in-law, said Sukhbir was particularly close to the family and had recently begun enjoying a married life. "He was like my child. They are five siblings — two brothers and three sisters. Their parents died early. His elder sister raised them,"

Singh told PTI. He said Sukhbir and Anju had met while working at NDMC and eventually fell in love.

"He and Anju had married a few years ago. They were working together in NDMC where they fell in love. Anju left her first husband and started living with Sukhbir," Singh said. "Sukhbir had also made a new home recently. They were very happy together, and it ended like this," he added. Recalling how Sukhbir's elder sisters had brought up the family after their parents' death, Singh said the tragedy had left them heartbroken.

"Think about the three sisters that raised him like a mother," he said.

Singh also appealed to the

government to provide compensation to the family and employment to Sukhbir's younger brother.

"We want the Government to compensate and give his younger brother his job in NDMC. He was working in NDMC since 2002 and recently got permanent," he said.

According to police, a preliminary inquiry has suggested that the motorcycle slipped on the road before they were run over.

Further investigation is underway to establish the exact sequence of events and circumstances leading to the fatal accident, they said.

Police said the vehicle and other relevant evidence were being examined as part of the investigation.

Delhi CM launches ATS, flags off 50 e-buses

Chief Minister Rekha Gupta inaugurated an Automated Testing Station (ATS) at the DTC's Tehkhanda Depot and public electric vehicle (EV) charging stations at the Hasanpur and Ghazipur depots. She also flagged off 50 new zero-emission electric buses and launched an interstate e-bus service between Delhi and Rewari. During the programme, the Chief Minister also unveiled a coffee table book on the DTC. The chief minister said the Delhi Government's aim was not merely to discuss problems but to provide lasting solutions.

Addressing the gathering, the chief minister said this is the second Automated Testing Station at Tehkhanda. The first ATS has already been started at Nand Nagri Depot. The four-lane automated testing centre at Tehkhanda will make vehicle fitness testing more scientific, transparent and technol-

ogy-driven. It will have two lanes for heavy motor vehicles, one for light motor vehicles and one for two-wheelers. The centre will have an annual testing capacity of 72,000 vehicles, including 52,000 heavy and light motor vehicles and 20,000 two-wheelers. This is the second Automated Testing Station at Tehkhanda. The first ATS has already been started at Nand Nagri Depot.

During the programme, 50 new 12-metre zero-emission electric buses were flagged off after being added to the DTC fleet. The chief minister said the government's aim was not only to increase the number of buses but also to provide better and dignified facilities to passengers. Old and dilapidated bus shelters across Delhi would also be modernised so that, along with modern buses, bus stops too looked attractive and convenient in keeping with the changing face of the city.

Delhi Transport Minister Pankaj Kumar Singh, South



Delhi MP Ramvir Singh Bidhuri, senior officials, public representatives and other dignitaries were present on the occasion.

She said passenger safety was the Government's top priority. Keeping this in mind, the new electric buses have been equipped with CCTV cameras, panic buttons and several other safety features.

Commenting on the previous Government's tenure, the Chief Minister said that at that time, there was more

concern about work and discussion about that concern than actual work. The DTC remained in debt for a long time, employees faced difficulties, and the problems of drivers, conductors and officials remained unresolved.

The Chief Minister also referred to the free bus travel scheme for women. She said 18 lakh women had so far obtained Pink Cards. With their addition, Delhi's total bus fleet has increased to around 6,840 buses, comprising 5,088 electric buses and 1,752 CNG buses. Delhi now has the country's largest electric bus fleet. The Delhi Government aims to increase the city's bus fleet to around 14,000 buses by the financial year 2028-29.

The Delhi Government also launched a zero-emission interstate e-bus service between Delhi and Rewari to strengthen green and convenient interstate connectivity. The service will operate on the Dhaura Kuan-Gurugram-Manesar-Dharuhera-Rewari route.

Transport Minister Pankaj Kumar Singh said the Automated Testing Station at Tehkhanda would enable fitness testing of around 72,000 vehicles annually. With the addition of 50 new electric buses, the DTC fleet would reach around 6,840 buses, including approximately 5,100 electric buses. The Delhi-Rewari interstate e-bus service and public EV charging stations at Hasanpur and Ghazipur had also been launched.

Woman stabbed to death by husband in hotel

A 28-year-old woman was allegedly stabbed to death by her husband inside a hotel in north Delhi's Lahori Gate area following a quarrel over a family dispute, and later attempted to take his own life, police said on Thursday.

The accused, identified as Prakash, 29, a resident of Phalodi in Rajasthan, allegedly attacked his wife Shivani with a knife inside a room at Hotel Prince before attempting to die by suicide, they said.

The couple married around six months ago and lived together in Rajasthan for about a month after their marriage. Shivani came to Delhi and started working at a beauty parlour, while Prakash, who used to run a tea shop in Phalodi, remained in Rajasthan, according to the preliminary investigation.

Police said Prakash arrived in Delhi a day before the incident and booked a room at Hotel Prince in the Lahori Gate police station area. Shivani later joined him. An argument broke out between the couple inside the room over a family

dispute during the night, following which Prakash allegedly attacked Shivani with a knife, police said.

After allegedly stabbing his wife, Prakash attempted to die by suicide, they said.

The incident came to light on Thursday morning when hotel staff found both of them unconscious. The staff informed the police, follow-



ing which a team reached the hotel and shifted the couple to a nearby hospital. Doctors declared Shivani 'brought dead', while Prakash was admitted for treatment. His condition is stated to be stable, police said.

Deputy Commissioner of Police (North) Niharika Bhatt said the preliminary investigation indicated that the husband had stabbed the woman, but the exact motive was yet to be ascertained. "Officials are trying to find out what led to the dispute and why the situation turned violent," the DCP said. Further investigation is underway.

Property dealer shot in Narela

Unidentified assailants fatally shot a property dealer outside a gymnasium in outer-north Delhi's Narela on Thursday morning, with police suspecting a possible gang rivalry behind the killing, an official said. The deceased has been identified as Pramod Dahiya, a resident of Haryana's Sonapat, he said.

Police said, the incident took place around 7 am when the attackers opened fire at Dahiya and fled the spot. Police teams are scanning CCTV footage from the area to identify the assailants and ascertain the sequence of events.

Police, in a statement, said they received a PCR call about the incident at 7.15 am. "One person, Pramod (42), was found dead due to multiple bullet injuries. 15 empty cartridges were also found at the spot," read the statement.

The deceased's brother, Pawan Kumar, who is an eye-witness, said that around 6:50 am, he and Pramod had come near The Gym, when two unknown persons fired at them. Both assailants fled the spot.

Police said the body has been sent for postmortem, and efforts are being made to identify and apprehend the assailants.
