# Xi, Kim Jong pledge deeper ties

Chinese President Xi Jinping and North Korean leader Kim Jong Un pledged mutual support and enhanced cooperation during talks in Beijing after a commemoration of the end of World War II, the countries' state media said.

Xi and Kim, along with top officials from their countries, met at Beijing's Great Hall of the People, a day after Kim attended a Chinese military parade alongside other foreign leaders, including Russian President Vladimir Putin.

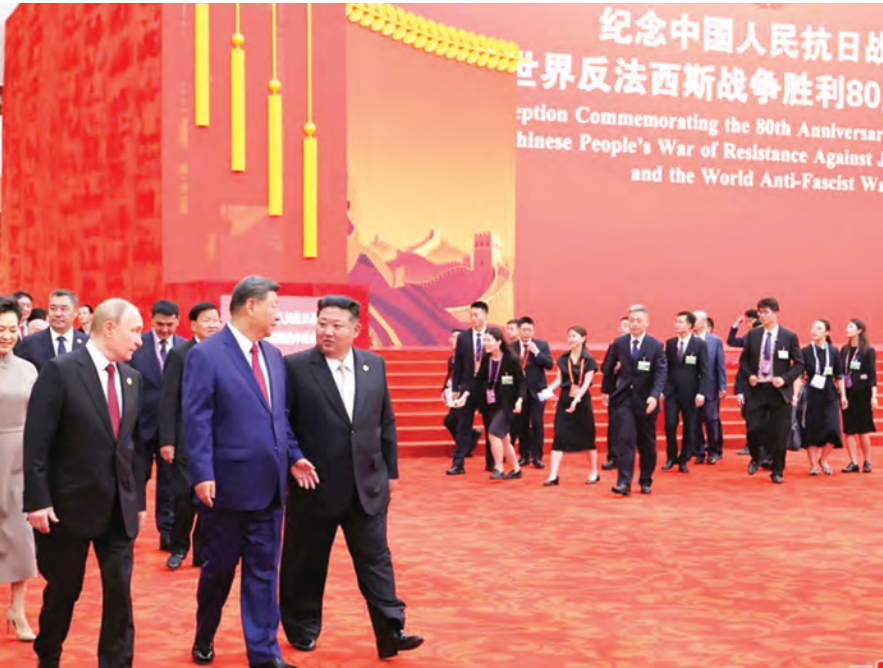
Kim is making a rare trip outside North Korea.

Xi highlighted the "traditional friendship" between China and North Korea and pledged to consolidate and boost relations, according to a readout of their statements published by Chinese State broadcaster CCTV.

"This position will not change regardless of how the international situation evolves," Xi told Kim, according to CCTV.

North Korea's official Korean Central News Agency said on Friday that the leaders discussed increasing high-level visits and contacts as well as strengthening strategic cooperation and protecting shared interests in international and regional affairs.

It said Kim left Beijing by his private train on Thursday evening after his meeting with Xi. China has been North Korea's biggest trading partner and aid provider, though questions



## KIM JONG TRIP TO CHINA MARKS TRANSFORMATION

**Tokyo:** Kim Jong Un put on a command performance this week at a gathering of some two dozen world leaders in China, striding with confidence and a broad grin across one of the biggest international stages of his 14-year career as North Korea's leader.

As Kim returns home on Friday, his time in Beijing marks a stunning transformation from his first tentative, violent years in power, when some analysts suggested the inexperienced young leader would struggle to survive threats to his rule.

Serious diplomacy with a large group of leaders was unimaginable. But in Beijing, Kim looked like the leader his propaganda services have constantly sought to portray: an important – crucial, even – player in world affairs, entirely at home with the biggest hitters in Eurasia. Beginning in 2018, when he and US President Donald Trump held the first of their much-publicized meetings, Kim has emerged as a far different, far more confident leader than when he was thrust into power after his father's death in 2011.

Granted, he is not yet appearing at the United Nations or established Western global forums. And the attendees in Beijing – which didn't include leaders from the US, Western Europe or Japan – showed little interest in pressing him on widespread concerns about human rights violations or his nuclear weapons. But the events this week are a watershed in his use of international diplomacy to advance his largely secluded nation's aims.

He deftly handled his two biggest allies, Chinese President Xi Jinping and Russian President Vladimir Putin, laughing with them, pledging enduring assistance to Moscow in its war against Ukraine, and strengthening a sometimes shaky relationship with China. He confidently rubbed shoulders with world leaders at a military parade marking the 80th anniversary of the end of World War II.

He even felt self-assured enough to bring his young daughter, and possible successor, along for the ride.

have lingered about the strength of their bilateral relationship. In recent years, Kim's foreign policy has focused heavily on Russia. He has sent combat troops and ammunition to back Russia's full-scale invasion of Ukraine in return for economic and military assistance.

At a meeting with Kim in Beijing after the parade, Putin praised the bravery of North Korean soldiers in the fighting. But experts say that Kim would feel the need to prepare for the possible end of the Russia-Ukraine war. Kim, on his first visit to China in six years, brought his young daughter, adding to speculation that she's being primed as the country's next leader.

On Wednesday, he joined 26 foreign leaders who watched the parade marking the 80th anniversary of the end of World War II. It was the first time that Kim joined an event with a large group of world leaders since taking office in late 2011.

North Korea's economy has been suffering under heavy US sanctions tied to Pyongyang's development of nuclear weapons. Some observers say Kim's trip could also be meant to increase leverage in potential talks with US President Donald Trump, who has repeatedly expressed his hopes to resume diplomacy between the two countries. China is believed to want its neighbour to return to negotiation and give up its nuclear weapons development.

# Pakistan, China launch second phase of CPEC, ink \$8.5 billion deals

Pakistan and China have formally launched the second phase of the controversial CPEC project and signed 21 agreements and joint ventures worth about \$8.5 billion.

The MoUs were signed in Beijing on Thursday, on the concluding day of Prime Minister Shehbaz Sharif's visit to China, when he met with Chinese Premier Li Qiang and attended an investors' conference.

According to the Dawn newspaper on Friday, the agreements covered cooperation in the development of China-Pakistan Economic Corridor (CPEC) 2.0, as well as in areas like science and technology, information technology, media, investment, and agriculture.

The total worth of the MoUs and joint ventures is about \$8.5 billion, it said. The PM Office in an official statement said during talks with Li, Shehbaz described the meeting as "most productive".

"Both sides also agreed to continue working closely on the next phase of the upgrad-



ed CPEC 2.0, with its five new corridors," it said.

India opposes the CPEC, which will link Xinjiang in China and the Gwadar port in Pakistan's Balochistan, as it passes through PoK. The CPEC is the flagship project of China's ambitious multi-billion-dollar Belt and Road Initiative (BRI).

The BRI is seen as an attempt by Beijing to further its influence abroad with infrastructure projects funded by Chinese investments all over the world.

The PMO statement said during the meeting, Prime Minister Sharif highlighted the "significant contribution" of

the CPEC to Pakistan's socio-economic development in the past decade.

He also stressed the need to accelerate the implementation of the Main Line-1 (ML-1) railway project, the realignment of the Karakoram Highway, and the operationalisation of the Gw--adar Port.

In a social media post on Thursday, Sharif said he "invited Chinese companies to enhance their investment footprint in Pakistan" and underlined that both sides agreed to advance their cooperation in IT, agriculture, minerals, textiles and industry.

# Anutin Charnvirakul elected as Thai PM in parliamentary vote

Veteran Thai politician Anutin Charnvirakul was elected Prime Minister on Friday after winning a parliamentary vote, according to an official tally.

The leader of the Bhumjaithai Party won a total of 311 votes, far exceeding the 247 required majority from the House of Representative's 492 active members. He and his Government are expected to take office in a few days after obtaining a formal appoint-

ment from King Maha Vajiralongkorn. Anutin, 58, succeeds Paetongtarn Shinawatra, who was dismissed by court order as prime minister last week after being found guilty of ethics violations over a politically compromising phone call with neighbouring Cambodia's Senate President Hun Sen. A border dispute between the two nations erupted into a deadly five-day armed conflict in July. Anutin, who's an elected member of the House, got up from his seat and walked around the

chamber to take pictures with other lawmakers when he was a few votes short from the winning total.

Anutin told reporters as he exited Parliament to visit his father in a hospital that he would work hard to solve the country's problems. "I intend to work with my full capability," he said. "I must work everyday and make the most out of it, with no day off." Videos published by Thai media showed Anutin laughing as he hugged his father who said he was "very happy to see this day."

# Foreign troops in Ukraine legitimate targets, says Putin

Russian President Vladimir Putin said on Friday that any foreign troops deployed to Ukraine before a peace agreement has been signed would be considered "legitimate targets" by Moscow's forces.

Putin's comments came hours after European leaders repledged their commitment to a potential peacekeeping force, a prospect that Moscow has repeatedly described as "unacceptable."

"If any troops appear there, especially now while fighting is ongoing, we assume that they will be legitimate targets," he said during a panel at the Eastern Economic Forum in the far eastern Russian city of Vladivostok. Putin also dismissed the idea of peacekeeping forces in Ukraine after a final peace deal, saying "no one should doubt" that Moscow would comply with a treaty to halt its 3½-year full-scale invasion of its neigh-

bour. He said that security guarantees would be needed for both Russia and Ukraine.

Kremlin spokesperson Dmitry Peskov later said that Moscow would need "legally binding documents" to outline such agreements. "Of course, you can't just take anybody's word for something," he told Russian news outlet Argumenty i Fakty.

Putin's comments follow remarks from French President Emmanuel Macron on Thursday that 26 of Ukraine's allies have pledged to deploy troops as a "reassurance force" for Ukraine once fighting ends.

Macron spoke after a meeting in Paris of the so-called coalition of the willing, a group of 35 countries that supported Ukraine.

## UKRAINE CONFLICT AFFECTING GLOBAL SOUTH: INDIA AT UNGA

**United Nations:** India has voiced regret over the Ukraine conflict's "collateral consequences", including prices of fuel, saying countries of the Global South have been left to fend for themselves, as Delhi underscored that diplomatic efforts hold the promise to end the war and bring lasting peace.

"India continues to remain concerned over the situation in Ukraine. We maintain that the loss of innocent lives is unacceptable, and no solution can be found on the battlefield," India's Permanent Representative to the UN, Ambassador Parvathaneni Harish, said.

Addressing the UN General Assembly debate on 'The situation in the temporarily occupied territories of Ukraine', Harish said India continues to "note with regret that the collateral consequences of the conflict, including prices of fuel, is affecting the world at large and particularly the countries of the Global South, which have been left to fend
