Sub.: Rectification of an inadvertent error in the disclosure of material event

Ref: Disclosure of Material Event-Agreement with Bharat Sanchar Nigam Limited dated April 03, 2024 at 16:59:47

In accordance with Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirement), Regulation, 2015, we provided a disclosure on April 03, 2024 at 16:59:47 regarding the Company entering into an agreement with Bharat Sanchar Nigam Limited ("BSNL") in Rohtak, Haryana, for services in both rural and urban area. Inadvertently in the mentioned disclosure, a typographical error was made regarding the revenue share between BSNL and SAR Televenture Limited for the Rohtak (Urban) Agreement. The initial disclosure stated the revenue share as 50:50 instead of the accurate revenue share of 51:49 under Annexure A of the NSE corporate announcement. Although this was an inadvertent error, we sincerely regret it and apologize for the same.

The updated disclosure is now provided to you with the rectification.

The Company has entered into a revenue-sharing agreement with BSNL, to deliver BSNL telecom services (including fixed, wireless, broadband, etc.) to end users at Rohtak, Haryana (both rural & urban).

The brief details of the agreement are as under:

1. Scope of Work: The scope of this project involves constructing, expanding, and maintaining the Optical Fiber Cables (OFC) network within residential and commercial complexes, as well as establishing interconnections between buildings using OFC. Additionally, it includes the installation and upkeep of overhead OFC backhaul from the nearest BSNL pickup point to the Optical Line Terminal (OLT) location. The project also covers establishing interconnectivity at the network operation center and offering

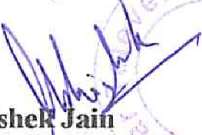

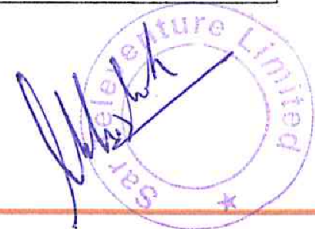
