This is to inform you that ICICI Prudential Mutual Fund (the Fund) including iSIF under its various schemes/investment strategies holds equity shares of Rategain Travel Technologies Ltd.(the Company), listed on your stock exchange.

The Fund under its schemes/investment strategies has carried out net sale of 3,67,090 shares of the Company on May 29, 2026. As a result, the shareholding of the Fund has decreased by more than 2% of the paid-up capital of the Company as compared to previous disclosure on February 20, 2025 for 5.06%.

It may be further noted that the schemes/investment strategies of the Fund have carried out net sale of 24,43,309 shares of the Company from the last filing submitted on February 20, 2025 (for positions held as on February 19, 2025).

The holding by schemes/investment strategies of the Fund are from an investment perspective and not with the objective of seeking any controlling interest.
