(II) As on date, the Company has confirmed orders aggregating to ₹1,139.10 crores (Excluding GST) for execution during FY 2026/2027, providing strong revenue visibility for the current financial year. Of these confirmed orders, ₹204.81 crores (in Q1) have already been billed and recognised as revenue during Q1 FY 2026/2027, with the balance orders scheduled for execution over the remaining period of the financial year.

In addition to the confirmed order book, the Company continues to witness a robust business opportunity pipeline and has submitted bids for projects aggregating to approximately ₹22,654 crores. Even considering a conservative conversion assumption of 10%, which is lower than the Company's historical win rate, the current pipeline presents significant potential for further order inflows and provides strong visibility for sustained growth.

Backed by the confirmed order book, strong execution momentum and a substantial bidding pipeline, the Company remains confident of achieving its previously communicated revenue **growth guidance** of approximately 70% for FY 2026/2027, over the revenue of approximately ₹823(Excluding GST) crores achieved in FY 2025/2026.

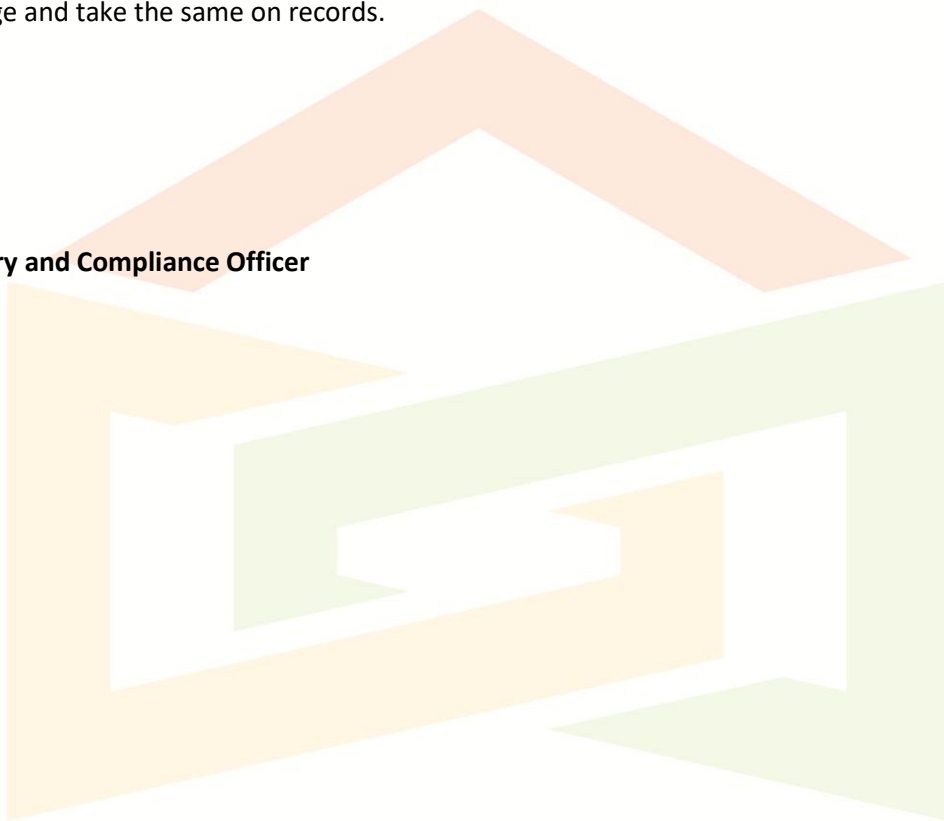
