1. Non-submission of disclosure for Utilization of Issue Proceeds:

At the outset, we regret the inadvertent delay in submission of the Fund Utilisation Certificate issued by the Statutory Auditors of the Company for the half year ended September 30, 2025. Being the first regulatory submission post listing, the same was inadvertently missed while submitting the half-yearly financial results on November 14, 2025.
