In pursuance of Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, SBC Exports Limited ("the Company") wish to inform you that Work Order for providing Manpower supply has been awarded to us by the Institute of Company Secretaries of India(ICSI), New Delhi vide Reference No. Ref No 6333/ 2025-26.

We are hereby submitting the Additional Details Required under SEBI Circular dated July 13, 2023(SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123), under Regulation 30 and 30A of SEBI (LODR) Regulations, 2015. - Additional details of Receiving of Order are as under:

- 1. Name of the entity awarding the order(s)/contract(s): Institute of Company Secretaries of India (ICSI).
- 2. Significant terms and conditions of order(s)/contract(s) awarded in brief:
 - a) The period of contract will be initially for a period of two (02) years w.e.f. 1st September 2025 subject to review of performance every Three (3) Months. The contract may be extendable at the discretion of ICSI subject to the satisfactory performance of the Vendor.
 - b) The vendor shall be required to deposit an amount Rs. 35,00,000/- (Rupees Thirty Five Lakh Only) as Security Deposit / performance guarantee in form of a Bank Guarantee/Demand Draft/Bank Cheque from any Nationalized bank.
 - c) The vendor shall deploy Trained, Qualified and Experienced manpower as per the requirement of the ICSI anywhere in India.
 - d) The vendor shall be responsible for and shall pay all taxes, duties, assessments or other charges of any kind or nature whatsoever levied by any government or governmental body on or in connection with the Services including without limitation all statutory levies, taxes, fee, duties, rate, charges, surcharges etc. and any other tax ("taxes") levied on service provided by the Service Provider. ICSI may withhold from payments due to the vendor any amounts required with respect to the aforementioned taxes and to remit the same with the relevant authorities, in case of failure on the part of the Service Provider.



- e) Arbitration: If, for any reason, such dispute cannot be resolved amicably by the Parties, the same shall be referred to the Arbitration process. In the event of any dispute arising between ICSI and the vendor in any matter covered/touched by this contract or arising directly or indirectly there from or connected or concerned with the said contract, the matter shall be referred to the sole arbitrator appointed by the mutual consent of both the parties. The decision / award of the Arbitrator shall be final and binding on the parties. Cost of Arbitration will be shared equally by the parties.
- 3. Whether order(s)/contract(s) have been awarded by domestic/international entity: **Domestic Entity.**
- 4. Nature of order(s)/contract(s): Order for supply of Manpower.
- 5. Time period by which the order(s)/contract(s) is to be executed: **2(Two) year from** the date of Purchase Order i.e. 01.09.2025.
- 6. Broad consideration or size of the order(s)/contract(s): INR ₹ 6,00,00,000/(Rupees Six Crore only)
