This is to inform you that ICICI Prudential Mutual Fund (the Fund) including iSIF under its various schemes/investment strategies holds equity shares of SBI Cards and Payment Services Ltd.(the Company), listed on your stock exchange.

The Fund under its schemes/investment strategies has carried out net acquisition of 21,60,916 shares of the Company on August 25, 2026. As a result, the shareholding of the Fund has increased by more than 2% of the paid-up capital of the Company as compared to previous disclosure on April 26, 2024 for 5.18%.

It may be further noted that the schemes/investment strategies of the Fund have carried out net acquisition of 2,01,71,877 shares of the Company from the last filing submitted on April 26, 2024 (for positions held as on April 25, 2024).

The holding by schemes/investment strategies of the Fund are from an investment perspective and not with the objective of seeking any controlling interest.
