Dear Sir,

I, Manisha Maheshwari, Partner of M/s. Bhandari & Associates, Company Secretaries, have been appointed as a Scrutinizer by the State Bank of India ("the Bank") for the purpose of scrutinizing the voting by electronic means i.e. remote e-voting and through e-voting system at the General Meeting ("GM") of the shareholders of the Bank, pursuant to the applicable provisions of the State Bank of India Act, 1955 read the State Bank of India General Regulations, 1955 and Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations") and Section 108 of the Companies Act, 2013 ("the Act") read with Rule 20 of the Companies (Management and Administration) Rules, 2014 as amended, on the resolutions contained in the Notice of the GM of the shareholders of the Bank dated February 10, 2026 read with its Corrigendum dated March 09, 2026, held on Friday, March 27, 2026 at 3.00 p.m. (IST) through Video Conferencing ("VC")/Other Audio Visual Means ("OAVM") in a fair and transparent manner.

The management of the Bank is responsible to ensure compliance with the provisions of the State Bank of India Act, 1955, the State Bank of India General Regulations, 1955, the Act and the rules made thereunder including Ministry of Corporate Affairs ("MCA") General Circular No. 14/2020 dated April 8, 2020 and the subsequent circulars issued in this regard from time to time, the latest being circular No. 03/2025 dated September 22, 2025 (hereinafter collectively referred to as "MCA Circulars") and the relevant Securities and Exchange Board of India ("SEBI") Circulars and other provisions of the Listing Regulations and the SEBI Master Circular No. SEBI/HO/AFD/AFD-PoD-2/P/CIR/2024/70 for Foreign Portfolio Investors, Designated Depository participants and Eligible Foreign Investors dated May 30, 2024 relating to voting through electronic means by remote e-voting and e-voting at the GM by the shareholders on the resolution proposed in the Notice of the GM of the Bank.



My responsibility as a scrutinizer for the e-voting process is restricted to prepare the Scrutinizer Report on the votes cast "in favour" or "against" the resolution(s) based on the reports generated from the e-voting system provided by the National Securities Depository Limited ("NSDL"), the authorized service provider for extending the facility of electronic voting to the shareholders of the Bank.

Further to the above, I submit my report as under:

- (i) Pursuant to the provisions of Regulation 44 of the Listing Regulations and Section 108 of the Act read with Rule 20 of the Companies (Management and Administration) Rules, 2014, MCA Circulars and SEBI Circulars, the Bank has availed the e-voting facility offered by NSDL for conducting remote e-voting prior to GM and e-voting at the GM by the Shareholders who attended the GM through VC / OAVM and who had not cast their vote through remote e-voting.
- (ii) In terms of MCA Circulars and SEBI Circulars, the Bank had sent the notice of GM in electronic form only to its shareholders who have registered their e-mail addresses with their respective Depository Participants.
- (iii) The GM Notice was published in the Gazette of India on February 12, 2026 and newspaper advertisement with respect to dispatch of notice of GM and conducting of voting through electronic means was published in an English and Hindi newspaper "Business Standard" and Marathi newspaper "Aapla Mahanagar" on February 13, 2026.
- (iv) The shareholders of the Bank holding shares since the cut-off date i.e. December 26, 2025 as provided in Regulation 31 of the State Bank of India General Regulations, 1955, were entitled to vote on the resolutions as set out in the Notice of the GM.
- (v) The voting period for remote e-voting commenced on Tuesday, March 24, 2026 at 10:00 A.M. and ends on Thursday, March 26, 2026 at 05:00 P.M. and thereafter, the voting portal was blocked forthwith.
- (vi) On Friday, March 27, 2026, after the conclusion of GM, the report on the e-voting carried at the GM and remote e-voting process were unblocked by me in the presence of two witnesses Mr. Saurabh Somani and Mr. Mit Shah.
- (vii) I have scrutinized and verified the votes cast through remote e-voting and e-voting at the GM based on the data generated from NSDL e-voting portal.
