HOLDING ADDITIONAL CHARGE OF DIRECTOR (T&OS)

Rear Admiral Jaswinder Singh is presently at the helm of the Liner and Passenger Services, and had also served as Director of Bulk and Tanker businesses of the Shipping Corporation of India (SCI) for 10 months till 04.05.2026. He had also served as a Director on the Board of SCI Bharat IFSC Ltd, a Wholly Owned Subsidiary of SCI till 23.02.2026. Thereafter, he has been appointed as a Director on the Board of Inland and Coastal Shipping Ltd. He has also been appointed as a Director on the Board of Sethusamudram Corporation Ltd. During his more than three and half decades of distinguished service in the Indian Navy, Chief of Staff of the Southern Naval Command, Assistant Chief of Naval Staff Foreign Cooperation, Principal Director at Naval Headquarters New Delhi, Command of Destroyer, Corvette and Training Establishment are some of the prestigious appointment held by the Admiral in top leadership role.
