The Shipping Corporation of India Limited (SCI) has received a favorable order from the Hon'ble CESTAT, Mumbai, in the referenced matter, wherein the impugned order dated 25.08.2016 has been set aside. Thereby, the Company is expecting reduction to the tune of ₹ 66.13 crore, comprising the principal demand, penalty, and interest, which had been earlier disclosed as a Contingent Liability in the Company's Financial Statements.
