Sub: Scrutinizer Report on Special Businesses proposed through Postal Ballot under Section 110 read with Section 108 of the Companies Act, 2013 and Rules 20 and 22 of the Companies (Management and Administration) Rules, 2014 (including any statutory modification or re-enactment thereof).

I, Mrs. Nidhi Thakar, Proprietor of M/s. ### I HEREBY REPORT AS UNDER:

- On the basis of the register of members and the list of beneficiary owners made available by the Depositories viz., National Securities depository Limited (NSDL), as on Wednesday, September 10, 2025 the Company completed dispatch of the Notice of the Postal Ballot;
- Through E-Mail on September 10, 2025 to the members whose E-Mail Id's are registered with company/depository participant.
- Those shareholders who had not registered their e-mail address were requested to get their e-mail addresses submitted, by following the procedure - (a) In case shares held in physical mode, by providing Folio No., Name of shareholder, scanned copy of the share certificate (front and back), PAN (self-attested scanned copy of PAN card), AADHAR (self-attested scanned copy of Aadhar Card) through email to http://www.salasarexterior.com/; (b) In case shares held in demat mode, by providing DPID-CLID (16 digit DPID + CLID or 16 digit beneficiary ID), Name, client master or copy of Consolidated Account statement, PAN (self-attested scanned copy of PAN card), AADHAR (self-attested scanned copy of Aadhar Card) through http://www.salasarexterior.com/; and (c) Alternatively by sending an e-mail request to evoting@nsdl.co.in for obtaining User ID and Password by providing the above mentioned documents as the case may be.
- 2. The Company had also placed the Notice of Postal Ballot on its web site <a href="http://www.salasarexterior.com/">http://www.salasarexterior.com/</a> as well as web site of E-voting Agency viz www.evoting.nsdl.com and website of National Stock Exchange of India Limited.
- 3. The Shareholders holding Shares as on the "Cut off date, i.e. Friday, September 5, 2025 were entitled to vote through remote e-voting platform on the businesses mentioned in the Notice of Postal Ballot of the Company.
- 4. In terms of the aforesaid Notice, remote e-voting was opened for thirty days which was commenced on Wednesday, September 10, 2025 (09:00 A.M.) and was ended on Friday, October 10, 2025 (05:00 P.M.) - After the Completion of Voting Period as mentioned above, I have scrutinized and reviewed the remote e-voting and votes tendered therein based on the data downloaded from the website of NSDL Remote E-voting Platform.
