Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, read with the SEBI Master Circulars and other applicable provisions, we are pleased to inform you that Sejal Glass and Glass Manufacturing Products LLC, the Company's subsidiary in the United Arab Emirates, has secured five significant Architectural Glass orders aggregating to approximately AED 27.6 Million equivalent to INR 71 Crores. These orders pertain to prestigious hospitality, residential and healthcare projects in the UAE and further strengthen the Company's presence in the GCC region.
