This has reference to your communication cited above seeking clarification on the recent significant movement in the share price/volume of *Sellowrap Industries Limited* (Formerly known as Sellowrap Industries Private Limited) ("the Company") in terms of Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and SEBI (Prohibition of Insider Trading) Regulations, 2015.
