નવી દિલ્હી, તા. ૨૩ જાન્યુઆરી ૨૦૨૫ થી ભારતે તેના પાસપોર્ટ રેન્કિંગમાં મોટો સુધારો નોંધાવ્યો છે, જે ૮૫મા સ્થાનેથી ૭૭મા સ્થાને પહોંચી ગયો છે. ભારતનો પાસપોર્ટ રેન્કિંગ આઠ સ્થાન ઉપર આવ્યો છે. ભારતને ૫૯ દેશોમાં વિઝા એક્સેસ મળી છે. ચાલો વિગતવાર જાણીએ કે પાસપોર્ટ રેન્કિંગની દ્રષ્ટિએ કયો દેશ ટોચ પર છે.



જાન્યુઆરી ૨૦૨૫ થી ભારતે તેના પાસપોર્ટ રેન્કિંગમાં મોટો સુધારો નોંધાવ્યો છે, જે ૮૫મા સ્થાનેથી ૭૭મા સ્થાને પહોંચી ગયો છે. ભારતનો પાસપોર્ટ રેન્કિંગ આઠ સ્થાન ઉપર આવ્યો છે. ભારતને ૫૯ દેશોમાં વિઝા એક્સેસ મળી છે. હેનલી પાસપોર્ટ ઈન્ડેક્સના રેન્કિંગમાં આ વાતની પુષ્ટિ થઈ છે. હેનલી પાસપોર્ટ ઈન્ડેક્સમાં સિંગાપોર ટોચનું સ્થાન જાળવી રાખ્યું છે, જેણે વિશ્વભરના ૨૨૭ સ્થળોમાંથી ૧૯૩ સ્થળોએ વિઝા-મુક્ત પ્રવેશ આપ્યો છે. જુલાઈ ૨૦૨૫ માં પ્રકાશિત થયેલ અંતર રેન્કિંગ ઈન્ડેક્સના અંતર

પૃથ્થક સ્થાને પહોંચી ગયું છે. યુકે અને યુએસ રેન્કિંગમાં નીચે આવ્યા છે. યુનાઈટેડ કિંગડમ ૧૮૯ દેશોમાં વિઝા-મુક્ત પ્રવેશ પૂરો પાડતા છઠ્ઠા સ્થાને પહોંચી ગયું છે. યુનાઈટેડ સ્ટેટ્સ હવે ૧૮૨ સ્થળોની એક્સેસ સાથે ૧૦૫મો સ્થાને છે. છેલ્લા દાયકામાં બંને દેશોના રેન્કિંગમાં સતત ઘટાડો થયો છે. નોંધનીય છે કે આ પહેલી વાર છે જ્યારે પાસપોર્ટ રેન્કિંગના સંદર્ભમાં યુએસ ટોચના ૧૦ માંથી બહાર નીકળી જવાનો ભય ધરાવે છે.

રાજપીપળા, તા. ૨૩ નર્મદા જિલ્લાના ડેડિયાપાડામાં દિલ્હીના પુર્વ મુખ્યમંત્રી અરવિંદ કેજરીવાલ તથા પંજાબના મુખ્યમંત્રી ભગવંત માનની જાહેરસભાને લઈને દર ગુરુવારે ડેડિયાપાડામાં ભરાતુ હાટ બજાર બંધ રાખવાનું ડેડિયાપાડા મામલતદારે જાહેરનામું બહાર પાડ્યું છે. ત્યારે હાટ બજાર બંધ રાખવા મુદ્દા નર્મદા જિલ્લાની રાજનીતિમાં ગરમાવો આવ્યો છે. ડેડિયાપાડાનું હાટ બજાર "સુરક્ષા" ને લીધે બંધ રાખવાનું કે "રાજકીય કાવા દાવા" ને લીધે બંધ રાખાયું હશે એ પ્રશ્ન ચર્ચાઈ રહ્યો છે. દર ગુરુવારે ડેડિયાપાડા એ.પી.એમ. સી. પાતે હાટ બજાર ભરાય છે. ગુરુવારે ૨૪ મી જુલાઈએ દિવાસના

મુંબઈ, તા. ૨૩ બુધવારે (૨૩ જુલાઈ) અડવાડિયાના ત્રીજા ટ્રેડિંગ દિવસે, સેન્સેક્સ ૫૪૦ પોઈન્ટ વધીને ૮૨,૭૨૭ પર બંધ થયો. નિફ્ટી ૧૫૯ પોઈન્ટ વધીને ૨૫,૨૨૦ પર બંધ થયો. સેન્સેક્સના ૩૦ શેરોમાંથી ૨૨ શેરમાં તેજ અને ૮ શેરમાં ઘટાડો રહ્યો. ટાટા મોટર્સ, એરટેલ અને બજાજ ફાઈનાન્સના શેર ૨.૫૫% સુધી વધ્યા.
