Dear Sir,

We are pleased to present our report on the Postal Ballot conducted by **Servotech Power Systems Limited** ("the Company") seeking consent of its members for the resolution as contained in the Notice of Postal Ballot dated September 23, 2024.

1. In terms of the provisions of Section 110 of the Companies Act, 2013 ("the Act") read with Companies (Management and Administration) Rules, 2014, we were appointed as the Scrutinizer by the Company on September 23, 2024 to conduct the Postal Ballot as contained in the Notice of Postal Ballot dated September 23, 2024 ("Postal Ballot Notice").

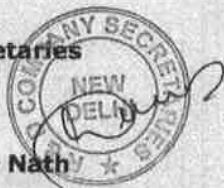

- 3.2. The Company had hosted the Postal Ballot Notice on its website and the website of NSDL ("e-voting Agency") and also intimated the same to National Stock Exchange of India Limited on **September 23, 2024**.
- 3.3. Pursuant to Rule 20 and 22 of the Companies (Management and Administration) Rules, 2014 and the relevant MCA Circulars, an Advertisement regarding the Postal Ballot was published on **September 25, 2024** in all editions of Financial Express in English language and Jansatta in Vernacular language.
4. In terms of the aforesaid notice, Members were required to convey their assent or dissent, only through e-voting system, on the e-voting platform provided by NSDL from 09:00 A.M. (IST) on Tuesday, September 24, 2024 till 05:00 P.M. (IST) on Wednesday, October 23, 2024.
5. Members' demographic details, their voting rights and voting pattern were downloaded by us from the NSDL e-voting platform.
6. All the votes cast by the members were found to be valid.
7. After the scrutiny of the e-voting results, we report that the Resolutions as contained in the Postal Ballot Notice has been passed with requisite majority.

The Board of Directors of the Company through its Meeting held on 23rd September, 2024 had appointed Mr. Debabrata Deb Nath, (FCS No.: 7775; CP No.: 8612) Partner, R&D Company Secretaries, Practicing Company Secretaries as the Scrutinizer for conducting the Postal Ballot by way of remote e-voting process in accordance with the Act and in a fair and transparent manner.
