- **EBITDA** increased by **59.14%**, standing at **Rs.2702.23 lacs** in Q3 FY26 from **Rs.1698.05 lacs** in Q3 FY25.
- **Gross Profit** rose by **68.08%**, standing at **Rs.5721.06 lacs** in Q3 FY26, up from **Rs.3403.84 lacs** in Q3 FY25.
