Yes. The Company has procedures in place for supplier selection which include evaluation of quality, regulatory compliance, and ethical practices. However, the Company is in the process of formalizing a comprehensive sustainable sourcing framework, and therefore the percentage of inputs sourced sustainably is not assessed.
3. Describe the processes in place to safely reclaim your products for reusing, recycling and disposing at the end of life, for (a) Plastics (including packaging) (b) E-waste (c) Hazardous waste and (d) other waste.
(a) Plastics (including packaging): The company follows a structured system for reduction, reuse, and recycling of plastic materials used in packaging and operations. Primary packaging materials are designed to be recyclable wherever possible. Plastic waste generated from manufacturing and packaging activities is segregated at source and handed over only to authorized recyclers. Secondary and tertiary packaging materials such as cartons, shrink wraps, and HDPE/LDPE materials are sent to approved vendors for recycling. The company also encourages reduction in single-use plastics and promotes use of eco-friendly alternatives.
(b) E-waste: E-waste generated from electrical and electronic equipment such as computers, laboratory instruments, and office electronics is collected separately and stored in designated areas. The disposal is carried out in accordance with applicable E-Waste Management Rules. The company ensures that all e-waste is handed over only to CPCB/SPCB-authorized e-waste recyclers for safe dismantling, recovery of useful materials, and environmentally sound disposal. Proper records of disposal and certificates from recyclers are maintained.
(c) Hazardous waste: Hazardous waste generated during manufacturing processes, such as solvent residues, chemical waste, and contaminated materials, is handled in compliance with applicable environmental regulations. Such waste is segregated, stored in secure and labeled containers, and disposed of only through authorized Treatment, Storage, and Disposal Facilities (TSDFs) or approved incineration units. The company ensures strict adherence to safety norms to prevent environmental contamination and health hazards.
(d) Other waste: Other waste such as non-hazardous industrial waste, paper, cardboard, and general waste is segregated at source. Recyclable materials are sent to authorized recyclers, while biodegradable waste is disposed of through composting or municipal waste management systems. The company promotes waste minimization practices and encourages reuse of materials wherever feasible to reduce overall environmental impact.
