Sub: Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“Listing Regulations”).

This is in continuation of our letter dated **December 17, 2025**, wherein we had intimated that the Reserve Bank of India (“RBI”) had approved the Company’s application for undertaking factoring business subject to certain conditions.

We now wish to inform you that the RBI has, on **January 07, 2026**, issued the **Certificate of Registration** to the Company for undertaking factoring business in accordance with the provisions of the Factoring Regulation Act, 2011 and the directions issued thereunder.

The Certificate has been granted subject to the following conditions:

- The Company shall ensure to commence the factoring business within 6 months from the date of grant of Certificate of Registration.
- The Company shall suitably amend the main clauses of its Memorandum of Association to include specific clause related to factoring business within 3 months of issuance of the additional Certificate of Registration (COR) and prior to starting the said factoring business.

The Company shall comply with the aforesaid condition and take necessary steps to operationalize the factoring business in accordance with the applicable regulatory framework.
