The figures for the quarter ended as on 31st March 2025 are the balancing figures between the
- 4 audited figures in respect of the full financial year 2024-2025 and published unaudited year to date figures up to third quarter ended on 31st Dec. 2024.  
The Company at its right issue committee meeting held on 12th October 2024 has allotted 14,13,000
- 5 rights equity shares of Face value of Rs. 10 each issued at a premium of Rs.315 per share, total price of Rs.325 per share. Company has raised Rs.4592.25 lakhs through this right issue. On 12th October 2024, allotment process was completed. Accordingly, as per Ind AS-33 Earnings per Share, E.P.S. of previous reporting periods are restated.
