With reference to above captioned subject matter this is to on form your good office that The Company had filed the Financial Results in XBRL format on 08th August, 2025 through the BSE Listing Portal. However, due to a genuine misunderstanding regarding the applicability of integrated filing for financial results, the same was not uploaded on the NSE NEAPS portal within the stipulated time.

Immediately upon receipt of NSE's email dated September 08, 2025, we submitted the XBRL file of the financial results with NSE on 09th September, 2025. A copy of the acknowledgment was enclosed with our earlier communication and is enclosed again herewith for your ready reference.

We sincerely regret this inadvertent lapse and respectfully submit that there was no wilful or intentional non-compliance, as the financial results in PDF format had already been filed with NSE within time. The delay occurred purely on account of an unintentional misinterpretation of the filing requirement.

Going forward, we have strengthened our internal compliance processes to ensure that financial results in XBRL format are filed simultaneously on both BSE and NSE portals to avoid recurrence of such instances.
