US envoy meets European leaders on Ukraine security

PTI KIVV

US special envoy Steve Witkoff met with European leaders in Paris on Thursday to discuss security guarantees for Ukraine, as allies seek to ensure long-term military support for the war-torn nation and secure continued American backing after the conflict ends. The envoy, named by US President Donald Trump to mediate peace talks, also plans to meet with Ukrainian President Volodymyr Zelenskyy at the Paris talks, an official in Ukraine's presidency said. The official spoke on condition of anonymity because they were not authorised to disclose information to the media.



Witkoff was invited to participate in the so-called "coalition of the willing" meeting to discuss aid for Ukraine, including sketching out plans for military support in the event of a ceasefire in the Russia-Ukraine war to deter future Russian aggression. French President Emmanuel Macron and British Prime Minister Keir Starmer, who lead the group, have insisted that any European "reassurance" force in Ukraine needs the backing of the United States. Macron said ahead of Thursday's meeting that preparatory work on the security guarantees had been done and should now be approved at the political level. He did not provide details. "We Europeans are ready to provide security guarantees to Ukraine and the Ukrainians on the day peace is signed," Macron

said. It is unclear what members of the coalition are willing to contribute, including troops on the ground.

20-year NASA veteran PIO named associate admin

A decorated Indian-American Amit Kshatriya has been named as NASA's new 'exploration-focussed' associate administrator, the US space agency announced here. Kshatriya, a 20-year NASA veteran, was most recently the deputy in charge of the Moon to Mars Programme in the Exploration Systems Development Mission Directorate (ESDMD) at the National Aeronautics and Space Administration (NASA) head-

quarters in Washington. "Acting NASA Administrator Sean P Duffy Wednesday named exploration-focussed Amit Kshatriya as the new associate administrator of NASA, the agency's top civil service role," a NASA statement said. Born in Wisconsin to Indian immigrant parents, educated at California Institute of Technology (CalTech) and the University of Texas at Austin, Kshatriya is one of only about 100 people in history to serve as a mission control flight director.

Judge reverses Trump admin's billion dollar cuts to Harvard

A federal judge in Boston on Wednesday ordered the Trump administration to reverse its cuts of more than \$2.6 billion in research funding for Harvard University, delivering a significant victory to the Ivy League school in its battle with the White House. US District Judge Allison Burroughs ruled the cuts amounted to illegal retaliation for Harvard's rejection of the Trump administration's demands for changes to Harvard's governance and policies. The government had tied the funding freezes to Harvard's delays in dealing with antisemitism, but the judge said the university's federally backed research had little connection to discrimination against Jews.



"A review of the administrative record makes it difficult to conclude anything other than that (the government) used antisemitism as a smokescreen for a targeted, ideologically-motivated assault on this country's premier universities," Burroughs wrote. The country must fight antisemitism, she wrote, but it also must protect the right to free speech.

The ruling reverses a series of funding freezes that later became outright cuts as the Trump administration escalated its fight with the nation's wealthiest university. The administration also has sought to prevent the school from hosting foreign students and threatened to revoke its tax-exempt status in a clash watched widely across higher education.

European leaders face tough choices

London: European countries are stuck between a rock and a hard place as a coalition of countries meets in Paris on Thursday to discuss security guarantees for a postwar Ukraine. The war is raging unabated, with no ceasefire in sight - and the crucial question of American involvement in ensuring Ukraine's future security remains unresolved. For months, the so-called "coalition of the willing" has been meeting to discuss aid for Ukraine, including sketching out plans for military support in the event of a ceasefire to deter future Russian aggression. The coalition leaders - French President Emmanuel Macron and UK Prime Minister Keir Starmer - have insisted that any European "reassurance" force in Ukraine needs the backing of the United States.
