Ground shift for stray...

The Court also extended its directions to address the issue of stray cattle and other animals on highways, roads, and expressways. It reaffirmed the directions earlier issued by the Rajasthan High Court, stating that public works departments, municipal authorities, and road and transport authorities must undertake a coordinated drive to immediately remove all stray cattle and other animals from highways and rehabilitate them in goshalas or shelter homes.

Each authority has been directed to constitute dedicated highway patrol teams to report stray cattle, and all National Highways will have helpline numbers to report the presence of such animals. The bench said that Chief Secretaries of all States and Union Territories must ensure strict enforcement of these directions and warned that officers will be held personally responsible for non-compliance.

The Court directed the States and the National Highways Authority of India (NHAI) to file status and compliance affidavits within eight weeks, indicating the mechanisms developed to carry out these directions.

Earlier, the Court had sought affidavits from all States and Union Territories on the implementation of the Animal Birth Control Rules, 2023. When many failed to comply, it summoned their Chief Secretaries, who appeared before the Court on November 3 and filed the required affidavits.

Top court rejects plea...

The counsel said the mosque was declared a Waqf property in 1985. "You need parking for some other religious place, and you demolish the mosque and say you do not have a right," the counsel argued. "Too late now, nothing can be done. Dismissed," the bench said, adding that the High Court has given reasoning in its order. Before the High Court, the petitioners had said they were residents of Ujjain and used to offer namaz in the mosque.

Earlier, the Division Bench had said, "The petitioners have no locus to seek reconstruction of the masjid. We do not find any ground to interfere with the order passed by the writ court."

deliberately removed stanzas of Vande Mataram which hailed Goddess Ma Durga." On the other hand, he insisted that, "The Congress Party takes immense pride in both Vande Mataram and Jana Gana Mana. Both songs are sung with reverence at every Congress gathering and event, symbolising India's unity and pride."

Now, Bhagavad...

The court is examining whether it was lawful for Trump to use emergency powers under the 1977 International Emergency Economic Powers Act (IEEPA) to impose sweeping reciprocal tariffs on several countries, including India. "The president is using these taxes to buy justice; he is using the tariffs to end the war in Russia and Ukraine, where he has told India 'stop buying oil,'" Lutnick said, adding that restricting these powers (IEEPA) would weaken Trump's ability to make "the world and the US a safer place." Expressing confidence, he said that the US President will win the case because "these powers protect America".

Justice Bagchi also clarified that there was no insinuation against the pilot in the preliminary report of the Aircraft Accident Investigation Bureau (AAIB). "One pilot asked whether the fuel was cut off by the other; the other said no. There's no suggestion of fault in that report," he noted.

Justice Sreedharan's

Justice Atul Sreedharan was transferred to the Allahabad High Court on October 18, days after the Supreme Court collegium modified its earlier recommendation for his transfer to Chhattisgarh High Court.

Justice Sreedharan was appointed as high court judge on April 7, 2016, and was transferred to the J&K and Ladakh High Court in 2023. Again, he was transferred back to the MP High Court in the recent past.

JD(S) leader H D Kumaraswamy on Friday said there will be no chief minister change in Karnataka as it is being speculated, as it is not easy for the Congress party to replace Siddaramaiah.

The union minister said, as Siddaramaiah was earlier with the JD(S), he and his party leaders were aware as to what he is capable of doing, which others don't know.

There have been speculations about the chief minister change in the state, when the Congress government reaches the halfway mark of its five-year term, after the 20th of this month, which is being referred to by some as "November revolution".

"I don't have any belief in

revolution, the discussions have been going on about revolution, but there will be no revolution in my opinion," Kumaraswamy told reporters in response to a question.

Asked if there will be no CM change in his opinion, he said, "nothing will happen. He (Siddaramaiah) was with us earlier, others don't know what he is. As he was with us earlier, we know what he is capable of doing." It is not easy for Congress to remove him. What discussions have happened between them (within the Congress), we have nothing to do with it," he added. Siddaramaiah had joined the grand old party in 2006 after his ouster from JD(S) of former Prime Minister Deve Gowda.
