- The above financial results of the Company have been prepared in accordance with the recognition and measurement principles laid down in the Indian Accounting Standard 34 "Interim Financial Reporting" ("Ind AS 34"), prescribed under Section 133 of the Companies Act, 2013 and other accounting principles generally accepted in India.
- Shareholders in the Annual General Meeting held on September 25, 2025 approved final dividend for the year ended March 31, 2025 of Rs. 12.34 crores (Rs. 1 per share), which was paid by the Company during the current quarter.
- On November 21, 2025, the Government of India notified the four Labour Codes — consolidating 29 existing labour laws. The Ministry of Labour & Employment has also issued draft Central Rules and FAQs to help assess the financial impact of these changes. Based on internal management assessment, actuary report and the best information available, and in line with ICAI guidance, the Company has recognised an incremental impact of gratuity and long term compensated absences of Rs. 4.10 crores, mainly due to the revised wage definition. It has been disclosed under "Employee Benefit Expenses" in the Statement of Unaudited Standalone Financial Results for the Quarter and nine months ended December 31, 2025. The Company continues to monitor the finalisation of Central/State Rules and further Government clarifications and will account for any additional impact as required.
