Dear Sir/Madam,

1. The Board of Directors of the Company at its meeting held on 11th February, 2026, appointed me, Mr. Dipesh Gosar of Dipesh Gosar & Co., Practicing Company Secretary, as the "Scrutinizer" for scrutinizing the postal ballot voting including e-voting process.

My responsibility as a Scrutinizer was restricted to scrutinize the e-voting process, in a fair and transparent manner and to prepare as Scrutinizer's Report of the votes cast in favour and against the resolutions stated in the Notice. My report is based on verification of data and reports generated from National Securities Depository Limited's (NSDL's) electronic platform, engaged by the Company to provide e-voting facility to its members.

2. I submit my report as under:

As per General Circular Nos. 14/2020 dated April 8, 2020, 17/2020 dated April 13, 2020, and subsequent circulars issued in this regard, the latest being 3/2025 dated September 22, 2025 issued by the Ministry of Corporate Affairs, the Company has sent the Postal Ballot Notice dated February 11, 2026 on the same day by email only to the members whose email ids were available with the Company / Registrar and Share Transfer Agent (RTA).

The notice of postal ballot was sent to the members whose name(s) appeared on the Register of Members / list of Beneficial Owners as received from National Securities Depository Limited (NSDL) / Central Depository Services (India) Limited (CDSL) as on cut-off date i.e., Friday, February 06, 2026.

The e-voting period commenced on Thursday, February 12, 2026 at 09.00 A.M. (IST) onwards and concluded on Friday, March 13, 2026 at 05.00 P.M. (IST).

- 2.1. Particulars of votes cast through electronic means only have been entered in the register separately maintained for the purpose.



- 2.2. Since there was no voting by physical postal ballot form, the question of keeping them under my safe custody before commencing the scrutiny does not arise.
- 2.3. The votes cast through electronic means were unblocked on Friday, March 13, 2026 at 5.12 P.M.
- 2.4. Votes cast through electronic means were scrutinized and the shareholding was matched / confirmed with the Register of Members of the Company / list of beneficiaries as on Friday, February 06, 2026.
- 2.5. Votes cast through electronic means up to 5.00 PM of March 13, 2026, being the last time and date fixed by the Company for voting through electronic means were considered for my scrutiny.
- 2.6. Since the voting on Postal Ballot process was conducted only through e-voting, reporting on number of envelopes containing postal ballot form received after due date, up to the date of this report and returned undelivered and finding of defaced or mutilated ballot paper does not arise.
