Subject : Voting Results and Scrutiniser’s Report of the e-voting at the 17th Annual General Meeting (“AGM”) of Eureka Forbes Limited (the “Company”) for the Financial Year 2025-26 as per Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“SEBI Listing Regulations”)

Dear Sir / Madam,

This is to inform you that the 17th AGM of the Company was held on Wednesday, August 19, 2026 at 12:00 Noon IST through Video Conferencing (“VC”) / Other Audio-Visual Means (“OAVM”) and the venue of the AGM was deemed to be the registered office of the Company situated at B1/B2, 7th Floor, 701, Marathon Innova, Ganpatrao Kadam Marg, Lower Parel, Mumbai – 400 013.

The Company had appointed National Securities Depository Limited (“NSDL”) to provide facility for voting through remote e-voting, e-voting during the AGM and participation in the AGM through VC/OAVM facility.

In terms of Section 108 of the Companies Act, 2013 and Rule 20 of the Companies (Management and Administration) Rules, 2014 and SEBI Listing Regulations, the Company had extended the remote e-voting facility to the Members of the Company in respect of the resolutions to be passed at the AGM. The remote e-voting commenced on Sunday, August 16, 2026 at 09:00 AM IST and ended on Tuesday, August 18, 2026 at 05:00 PM IST. The facility for voting through e-voting system was also made available during the AGM for Members who had not cast their vote prior to the Meeting and the voting facility was also available for 15 minutes after the conclusion of the Meeting.

Pursuant to Regulation 44 of the SEBI Listing Regulations, we are enclosing the Consolidated Report (remote e-voting and e-voting during the Meeting) of the 17th AGM of the Company held on Wednesday, August 19, 2026 at 12:00 Noon IST in the prescribed format together with Scrutiniser’s Report submitted by M/s. Mihen Halani & Associates, Practicing Company Secretaries engaged as Scrutinizer.

Sub: Consolidated Scrutinizer's Report on voting through electronic means in terms of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management & Administration) Rules, 2014 for 17th Annual General Meeting ("17th AGM / the Meeting") of the Members of Eureka Forbes Limited ("the Company") held on Wednesday, August 19, 2026, at 12.00 Noon IST through Video Conferencing ("VC") or Other Audio Visual Means ("OAVM")

We, M/s. Mihen Halani & Associates, Practicing Company Secretaries (Proprietor Mihen Halani, FCS - 9926), appointed by the Board of Directors of the Company as Scrutinizer to scrutinize the e-voting process in accordance with section 108 of the Companies Act, 2013 ("the Act") read with Rule 20 of the Companies (Management and Administration) Rules, 2014 and General Circular Nos. 14/2020 dated April 8, 2020 and 17/2020 dated April 13, 2020, in relation to "Clarification on passing of ordinary and special resolutions by companies under the Companies Act, 2013", General Circular Nos. 20/2020 dated May 5, 2020, 10/2022 dated December 28, 2022 and subsequent circulars issued in this regard, the latest being 03/2025 dated 22nd September, 2025, as amended from time to time, issued by the Ministry of Corporate Affairs and Securities and Exchange Board of India ('SEBI'), vide its Circulars dated May 12, 2020, January 15, 2021, May 13, 2022, January 5, 2023, October 7, 2023 and October 3, 2024 ("SEBI Circulars"), and applicable provisions of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI LODR Regulations"), Secretarial Standard on General Meetings ("SS-2") issued by the Institute of Company Secretaries of India and other applicable laws, rules and regulations (including any statutory modification or re-enactment thereof for the time being in force and as amended from time to time), for 17th AGM of the Company held through Video Conferencing ("VC").

1. As confirmed by the Company, the Notice of 17th AGM was sent through electronic mode to those Members whose email addresses were registered with the Registrar and Share Transfer Agent of the Company / Depository Participant(s). In accordance with the provisions of Regulation 36(1)(b) of the SEBI LODR Regulations, the Company had sent a letter to those Members whose e-mail addresses were not registered with the Company/ Depository Participant(s) / Registrar and Share Transfer Agent,

providing the weblink of Company's website from where the Annual Report could be accessed and downloaded.

2. The Members of the Company on cut-off date, i.e. Wednesday, August 12, 2026, were entitled to vote on the resolutions (as set out in the notice of 17th AGM of the Company).
3. The Company had availed the e-voting facility provided by National Securities Depository Limited (NSDL). The remote e-voting period commenced on Sunday, August 16, 2026, at 09:00 AM IST and ended on Tuesday, August 18, 2026, at 05:00 PM IST (both days inclusive) ("remote e-voting period").
4. The Company had also availed e-voting facility provided by NSDL to the Members present at the AGM through VC and who had not cast their vote during the said remote e-voting period.
5. Post conclusion of the Meeting, the votes cast during the remote e-voting period and during the Meeting were unblocked in the presence of two witnesses, Mr. Milin Ramani and Ms. Janhavi Kulkarni who are not in the employment of the Company and counted thereafter. 6. On the basis of the votes exercised by the Members of the Company by way of remote e-voting and e-voting at the AGM, we have issued the Combined Scrutiniser's Report dated August 19, 2026.
7. The register has been maintained electronically to record the assent or dissent, received, mentioning the particulars of name, address, folio number or DP ID / Client ID of the Members, number of shares held by them and nominal value of such shares. There were no shares with differential voting rights in the Company. Hence, there is no requirement to maintain the list of shares with differential voting rights.
8. The Management of the Company is responsible for ensuring compliance with the requirements of the Companies Act, 2013 and rules relating to voting through electronic means on the resolutions contained in the Notice of the 17th AGM of the Company. Our responsibility as the scrutinizer for the remote e-voting / e-voting process is restricted to make a Scrutinizer Report of the vote cast in favour / against the resolutions stated above, based on the reports generated by the e-voting system provided by the NSDL, the authorized agency to provide e-voting facilities, engaged by the Company for the purpose.
