Notes:

- 1) The above unaudited standalone and consolidated financial results of the Company for the quarter and nine months period ended 31st December 2025 have been reviewed by the Audit Committee and thereafter approved by the Board of Directors at their respective meetings held on 12th February 2026.
- 2) To optimize focus on its core kitchen appliance segment, the Board of Directors, on 12th August 2025, approved the discontinuation of several high-loss product categories viz. air coolers (other than through the e-commerce channel), ceiling and other fans, air purifiers, water purifiers, and furniture fitting (the "Discontinued Product Categories"). This strategic exit resulted in the following financial adjustments during the nine months period ended 31st December 2025:
 - a) This led to two financial impacts in the quarter ended 30th June 2025, viz. (i) the recognition of ₹6.00 crore as "Other income" (per Ind AS 116) from an associated warehouse lease termination, and (ii) a provision of ₹49.49 crore as an "Exceptional Item" based on a preliminary assessment of the realisable value of discontinued assets.
 - b) During the quarter ended 31st December 2025, the Company recorded a reversal of provision amounting to ₹4.60 crore (previous quarter ended 30th September 2025: ₹0.61 crore) on account of disposal of assets related to Discontinued Product Categories. Consequently, the net Exceptional Item for the nine months period ended 31st December 2025, stands adjusted to ₹44.28 crore.
 - c) The corresponding sale proceeds of the Discontinued Product Categories amounting to ₹7.78 crore and ₹0.89 crore for the quarter ended 31st December 2025 and 30th September 2025 respectively have been recognized under "Revenue from Operations," with the sale proceeds from these Discontinued Product Categories approximating to their original cost.
- 3) Following the notification of the four Labour Codes by the Government of India on 21st November 2025, the Company has evaluated the financial implications based on draft Central Rules, and guidance issued by the ICAI. Given the regulatory-driven and non-recurring nature of these changes, the resulting incremental impact on employee benefit obligations comprising gratuity and compensated absences amounting to ₹0.68 crore and ₹4.65 crore on standalone and consolidated basis respectively, has been recognized as an "Exceptional Item" for the quarter and nine months period ended 31st December 2025. The Company remains engaged in monitoring the finalization of Central and State Rules and will incorporate any further accounting adjustments as additional clarifications are issued by the Government.
- 4) On a standalone basis, "Other Income" for the nine months period ended 31st December 2025 includes a dividend of ₹0.49 crore received from the Company's subsidiary, Hindware Limited, compared to ₹4.90 crore received during the corresponding previous period.
- 5) On 27th March 2025, the Board approved a Composite Scheme of Arrangement (the "Scheme") involving the Company, Hindware Limited, and HHIL Limited. The Scheme provides for the demerger of the Company's Consumer Products Business into HHIL Limited and the subsequent amalgamation of the remaining Company with Hindware Limited, with an Appointed Date of 01st April 2025. Pursuant to the approval received from the stock exchanges (BSE and NSE), the Company has filed an application for approval of the Scheme with the NCLT. The Scheme is subject to the approval of the shareholders, creditors of the Company and such other necessary approvals as may be required and sanction thereof by the NCLT.
- 6) The previous quarter/period/year figures have been rearranged/regrouped, wherever considered necessary.
- 7) The Statutory auditors of the Company have carried out a limited review of the above unaudited results.

We did not review the unaudited interim financial results and other financial information in respect of five (5) subsidiaries included in the consolidated unaudited financial results, whose interim financial information reflect total income of Rs. 0.03 crore and Rs. 0.08 crore for the quarter and nine months ended 31st December 2025, respectively, total net profit /(loss) after tax of (Rs.0.13 crore) and (Rs.0.33 crore) for the quarter and nine months ended 31st December 2025 respectively, total comprehensive income of (Rs. 0.13 crore) and (Rs. 0.34 crore) for the quarter and nine



months ended 31st December 2025 respectively as considered in the Statement. According to the information and explanations given to us by the Management, these interim financial results which are approved and certified by the management and other financial information are not material to the Group.

7. Some of these subsidiaries are located outside India whose financial results have been prepared in accordance with accounting principles generally accepted in their respective countries and which have been provided by the management of the subsidiaries under generally accepted auditing standards applicable in their respective countries. The Company's management has converted the unaudited financial results of such subsidiaries located outside India in accounting principles generally accepted in India and is based on the management certified financial statements and conversion adjustments prepared by the management of the Company and reviewed by us.

Our conclusion on the Statement is not modified in respect of the above matters.
