Statehood day marked with folk arts at Delhi Secretariat



Folk dances and traditional music took centre stage at the Delhi Secretariat on Friday as the Government organised a cultural programme to celebrate the statehood day of Uttar Pradesh, Himachal Pradesh and Dadra and Nagar Haveli. Organised under the aegis of the Sahitya Kala Parishad, the programme saw participation from three cultural troupes comprising 28 folk artists, according to a statement. The event, organised by the Delhi Government, featured performances from Uttar Pradesh, Himachal Pradesh and Dadra and Nagar Haveli as part of the ongoing series of Statehood Day celebrations, the statement read. The artistes presented traditional dance and music forms in regional attire, offering a glimpse into the cultural heritage, it stated. Chief Minister Rekha Gupta conveyed greetings on the occasion, while Minister for Art, Culture and Language Kapil Mishra said such platforms were important for preserving folk traditions and encouraging cultural exchange.



Delhi metro to start early at 3 am on Republic Day

The Delhi Metro Rail Corporation (DMRC) announced on Friday that metro services on all lines will begin at 3 am on January 26. The early start is aimed at facilitating the movement of people attending the Republic Day celebrations at Kartavya Path. In a statement, the DMRC said trains will run at a frequency of 15 minutes on all lines from 3 am to 6 am. After 6 am, metro services will operate according to the regular timetable for the rest of the day. The corporation said that parking facilities at all metro stations will remain operational on Republic Day to provide additional convenience to commuters. The National Capital Region Transport Corporation (NCRTC) said enhanced security checks will be in place at all Namto Bharat stations on the Delhi-Ghaziabad-Meerut corridor. The NCRTC said parking facilities at the New Ashok Nagar and Anand Vihar Namto Bharat stations will remain closed from 2 pm on January 25 to 2 pm on January 26 as part of the security arrangements.

FIR filed against Gurpatwant Singh Pannun over Republic Day threats

The Delhi Police Special Cell has registered an FIR against Sikhs for Justice (SFJ) designated terrorist Gurpatwant Singh Pannun for allegedly issuing threats to create unrest in the national capital ahead of Republic Day. The case has been registered under sections 196 (promoting enmity between different groups on ground of religion, race, place of birth, residence, language, etc, and doing acts prejudicial to maintenance of harmony), 197 (imputations and assertions prejudicial to national integration), 152 (acts endangering sovereignty, unity and integrity of India) and 61 (criminal conspiracy) of the Bharatiya Nyaya Sanhita (BNS), police said. According to police, the action was initiated after Pannun released a video



message on social media in which he allegedly threatened to disturb peace and law and order in Delhi before the Republic Day celebrations on January 26. In the video, Pannun claimed that his "sleepers" had pasted pro-Khalistan posters in parts of the city, including Rohini in northwest Delhi and

Dabri in southwest Delhi, as part of a larger conspiracy to incite unrest. Senior police officers said the video was circulated widely on social media platforms and was aimed at spreading fear among the public and provoking disharmony. "The content of the video is provocative in nature and poses a threat to public order, espe-

cially in view of the heightened security arrangements ahead of January 26," an officer said.

Following the claims made in the video, multiple teams of the Special Cell and local police units conducted searches in the mentioned areas. However, no pro-Khalistan posters or related material were found during the verification drive, the officer said.

"The claims made by Pannun regarding posters being put up in Rohini and Dabri have not been substantiated so far. Despite extensive checks and coordination with local police stations, no such posters have been recovered," the officer added. The Special Cell said further investigation is underway to assess the intent, reach and potential impact of the video, and additional legal action will be taken as per the findings.

Assembly Secretariat seeks FIR and FSL records on Atishi video

The Delhi Assembly Secretariat on Friday wrote to the Punjab police chief seeking copies of documents, including the FIR and forensics report, related to a purported video clip of Leader of Opposition Atishi in which she is seen making derogatory remarks against Sikh gurus. This comes a day after, Punjab Director General of Police (DGP) Gaurav Yadav in his reply to the Delhi Assembly secretary regarding the FIR registered in connection with the "doctored" video clip, had said that police acted in accordance with the law and the material available on record. The assembly secretariat also issued a reminder to the Forensic Science Laboratory (FSL), Punjab, asking it to submit pending forensic records related to

the FIR registered in Jalandhar by January 28. The letter, dated January 23 and issued by the secretary of the Delhi assembly, says that the previous reply from the Punjab Police chief, along with comments from the Jalandhar Commissioner of Police, has been placed before Speaker Vijender Gupta. The assembly noted that specific information and documents requested in an earlier notice on January 10 are still required for further directions. The Punjab Police have now been directed to provide copies of the original complaint, the FIR, reports from social media experts and the technical cell, and the findings of the Punjab Forensic Science Laboratory (FSL) by January 28. Earlier directed to be submitted by January 22, through a communication issued on January 16 by the assembly secretary.

DU approves new department of Medical Genetics at MAMC

The University of Delhi has granted academic and regulatory approval for starting a Department of Medical Genetics at Maulana Azad Medical College (MAMC) and its associated Lok Nayak Hospital. Delhi Health Minister Dr Pankaj Kumar Singh stated that the approval will significantly strengthen Delhi's public health-care ecosystem by introducing precision medicine, clinical genetics, and care for rare diseases within Government hospitals. The approval of two Doctorate of Medicine super-specialty seats has also been sanctioned, enabling structured training of specialists and expanding access to advanced genetic diagnostics and therapies for patients across Delhi. The department will address genetic disorders across all age groups, from fetal and neonatal stages to adulthood and geriatric care, with a strong focus on pediatric and rare diseases.

CM participates in mega blood donation camp
