**Subject: Intimation regarding withdrawal of the Draft Red Herring Prospectus dated 18<sup>th</sup> September, 2024 ("DRHP") filed with the National Stock Exchange of India Limited and Securities and Exchange Board of India ("SEBI") by Active Infrastructures Limited.**

In continuation to our earlier communication dated 18th September, 2024, and with reference to the Outcome of Board Meeting dated 16th January, 2024, informing that **Active Infrastructures Limited** [Formerly **Active Infrastructures Private Limited**] Subsidiary Company under Section 2 (87) of the Companies Act, 2013 has filed a Draft Red Herring Prospectus [On Fixed Price Issue basis] on **18<sup>th</sup> September, 2024** with National Stock Exchange of India Limited [SME e-merge Platform] for an Initial Public Offer (IPO) comprising of a fresh issue of up to 43,00,200 Equity Shares of Rs.5/- each and other applicable laws (the "Offer"). In connection with the offer, it has been informed by **Active Infrastructures Limited** that its Board of Directors ("Board") through a resolution passed in the Board Meeting dated 04<sup>th</sup> December, 2024, has decided to withdraw the Draft Prospectus filed with NSE & SEBI stating the reason that The decision is based on the fact that the Company closely monitoring the current market conditions, which have recently improved and stabilized. The Company believes that submission of the updated Draft Red Herring Prospectus (DRHP) at this point will place the company in a better position for a successful offering.

It is further stated that the company **Active Infrastructures Limited** requires more time to fine-tune our business strategy which includes making necessary adjustments to Company's product offerings and market focus to ensure a clearer and more compelling proposition for potential investors. The Company also plans to update the financial data and conduct further
