The Board of Directors of the Company have, at their Meeting No.2 of the FY 2023-2024 held on Saturday, the 27th May, 2023 decided to provide the Equity Shareholders (Members) of the Company, whose names appear as on Saturday, the 15th day of July, 2023 [**"Cut-off (Record Date)"**], a facility to exercise their right to Vote, on all the Ordinary/ Special Resolution/s as set out in the Notice of Saturday, the 15th day of July 2023 [**"Twenty Sixth (26th) AGM Notice"**], to be held on Saturday, the 22nd July, 2023 at 11:30 A.M. through Video-Conferencing (VC) or Other Audio-Visual Means (OAVM), by Electronic Means [Remote e-Voting as well as e-Voting during the Meeting (26th AGM)], through e-Voting System or Platform of Central Depository Services (India) Limited ("**CSDL**") for the Equity Shareholders (Members) of the Company.
