This is with reference to the subject and pursuant to the provisions of Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulation, 2015, it is to inform you that, the unlisted material subsidiary Company, M/s Suntech Infraestate Nagpur Private Limited, has been informed the Company on 28th December 2023, regarding receipt of the Notices dated 26th December 2023 from "Office of Sub-Divisional Officer and Land Acquisition Officer" for the amount of compensation payable to the Company, under sub Section 37 (2) of Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act 2013, and received by the Company on 28th December 2023 in the matter of compulsory acquisition of land for the extension of DP road from 30 Mtr to 33 Mtr under the project "**Mouja Sitaburdi, Tah- Nagpur (City), District Nagpur, Nagpur City approved Development scheme under Road widening development scheme from 30 Mtr to 33 Mtr at sitaburdi, Kamthi Road Patni Automobile to LIC Square**" for City Land Survey No. of Land Acquisition 2080 and 2081, respectively, for the land owned by the Suntech Infraestate Nagpur Private Limited, which are under compulsory acquisition for the aforesaid project.

As per the Notices from "Office of Sub-Divisional Officer and Land Acquisition Officer", the Company is entitled to receive the consideration of Compensation of Rs. 2,78,013/- and Rs. 4,81,01,775/- for City Land Survey No. of Land Acquisition 2080 and 2081, respectively, under the Road widening development scheme. The total amount of approved compensation is **Rs. 4,83,79,788/- (Rs. Four Crores Eighty Three Lacs Seventy Nine Thousand Seven Hundred Eighty- Eight Only).**
