Dear Sir / Madam,

Pursuant to Regulation 30 read with Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we wish to inform that the Board of Directors of the Company, at its meeting held on **03 December 2025**, approved the acquisition of **100% of the preference share capital** of **Suntech Infraestate Nagpur Private Limited**, a wholly-owned subsidiary of the Company, from **Riaan Ventures Private Limited**, for a cash consideration not exceeding **₹11.60 Crores**, subject to shareholder approval.

The transaction, being a Related Party Transaction, was approved by the shareholders at the Extra-Ordinary General Meeting held on **27<sup>th</sup> December 2025**. The acquisition has been completed on **30 December 2025**. Post-acquisition, the Company holds **100% control in terms of both equity and preference share capital** of the subsidiary.

The acquisition is in the ordinary course of business and aligned with the Company’s existing line of business. The details of aforesaid acquisition is Attached as an Annexure-A.
