मसूदा थाना क्षेत्र में मई 2022 में हुए इब्राहिम हत्याकाण्ड के आरोपियों की गिरफ्तारी नहीं होने से नाराज परिजन व ग्रामीणों ने बुधवार को कलेक्ट्रेट पहुंचकर धरना दिया। उन्होंने आरोपियों की गिरफ्तारी की मांग करते हुए प्रदर्शन किया। मसूदा थाना पुलिस पर भी कार्यवाही नहीं करने का आरोप लगाते हुए नारेबाजी की। साथ ही आरोपियों की गिरफ्तारी नहीं होने तक मृतक का भाई आमरण अनशन पर बैठ गया। मामले की गंभीरता को देखते हुए प्रशासनिक व पुलिस अधिकारियों ने एक माह के भीतर हत्याकाण्ड का पर्दाफाश करने की समझाइश कर मामले को शांत कराया। जिस पर धरना स्थगित कर दिया। ग्राम हरराजपुरा, मसूदा निवासी इकरामुद्दीन पुत्र इस्माल ने बताया कि उसके भाई इब्राहिम उर्फ कालू की 16 मई 2022

को हत्या हुई थी। जिसका मुकदमा भी मसूदा थाने में दर्ज कराया गया था। लेकिन पुलिस ने 9 माहों बाद भी आरोपियों को गिरफ्तार नहीं किया है। वह खुले आम घूम रहे हैं। इससे परिजनों सहित समाज व ग्रामवासियों में भारी रोष है। परिजन व ग्रामीण आज ग्राम हरराजपुरा के सरपंच मोहम्मद इकबाल के नेतृत्व में कलेक्ट्रेट पहुंच गए। जिन्होंने इब्राहिम हत्याकाण्ड के आरोपियों की गिरफ्तारी नहीं होने पर नाराजगी जाहिर करते नारेबाजी कर प्रदर्शन किया। साथ ही इकरामुद्दीन ने भाई के हत्यारों की गिरफ्तारी नहीं होने तक कलेक्ट्रेट के बाहर आमरण अनशन पर बैठने की बात कही थी। इस दौरान कांग्रेस की

परिजन का आरोप था कि थाना स्तर से लेकर पुलिस के उच्चाधिकारियों तक मामले में शिकायत की जा चुकी है। लेकिन आरोपी अभी तक नहीं पकड़े गए हैं। ऐसे में पुलिस अधिकारियों ने भी इसे गंभीरता से लिया। कुछ देर बाद ग्रामीण व मृतक के परिजन को मसूदा क्षेत्र के डीएसपी ईश्वरलाल व अन्य अधिकारियों ने समझाइश की। साथ ही उन्होंने एक माह के अन्दर हत्याकाण्ड का पर्दाफाश करने का भरोसा दिलाया। जिस पर ग्रामीण शांत हो गए। सरपंच मोहम्मद इकबाल ने बताया कि फिलहाल अधिकारियों पर विश्वास कर धरना स्थगित किया है। अगर एक माह बाद भी हत्यारों को गिरफ्तार नहीं किया गया तो और बड़े स्तर पर आन्दोलन किया जाएगा। इस दौरान धरने पर मृतक के भाई इकरामुद्दीन के साथ प्रोफेसर जलालुद्दीन, रमेश काठाट, सिकन्दर चीता, इब्राहिम काठाट, इफतेकार खान सहित समाज के अनेक लोग उपस्थित थे।
