With reference to the above-mentioned subject, we hereby inform you that **Shreeji Global IFSC Private Limited, a wholly owned subsidiary of Shreeji Shipping Global Limited**, has entered into a **Time Charter Party Agreement*** with **AMNS Shipping and Logistics Private Limited** (CIN: U63000GJ2021PTC126941) for deployment of its vessel **"MV SJ LILY"** (commercial name: MV SJ LILY) **for coastal cargo movement along the Indian coastline and delivery for the same has been made on 1st December, 2025.**

Shreeji Shipping has been steadily planting the foundations for long-term expansion, and the deployment of MV SJ LILY for AMNS represents one of the first visible outcomes of this strategic vision taking shape. By entering coastal movement, the company is evolving from lighterage & stevedoring services provider to a fully integrated maritime logistics player—broadening its service portfolio, unlocking new annuity-style revenue streams, and strengthening business resilience through asset-backed operations. Coastal shipping is a rapidly emerging opportunity in India, strongly encouraged by the Government because it is significantly more cost-efficient than road and rail, eases pressure on national highways, reduces fuel usage, and meaningfully cuts carbon emissions. These structural advantages are driving major industrial customers to shift their bulk cargo to coastal routes, creating a multi-year demand cycle for reliable coastal operators. Shreeji's early entry into this space, backed by owned vessels and established port relationships, positions it ahead of competition in a segment with high barriers to entry and limited organized players. Although this is just the beginning, the new coastal division has the potential to become a transformational growth engine for the company—enhancing scale, improving revenue quality, and elevating Shreeji's profile as a comprehensive logistics solutions provider.

Further, the Company is actively engaged in discussions with multiple industry participants for exploring coastal deployment opportunities to support their cargo movement requirements. These business development efforts reflect the Company's intent to broaden its service spectrum beyond stevedoring and cargo handling into coastal transportation, reinforcing belief in coastal movement as an emerging national logistics priority.
