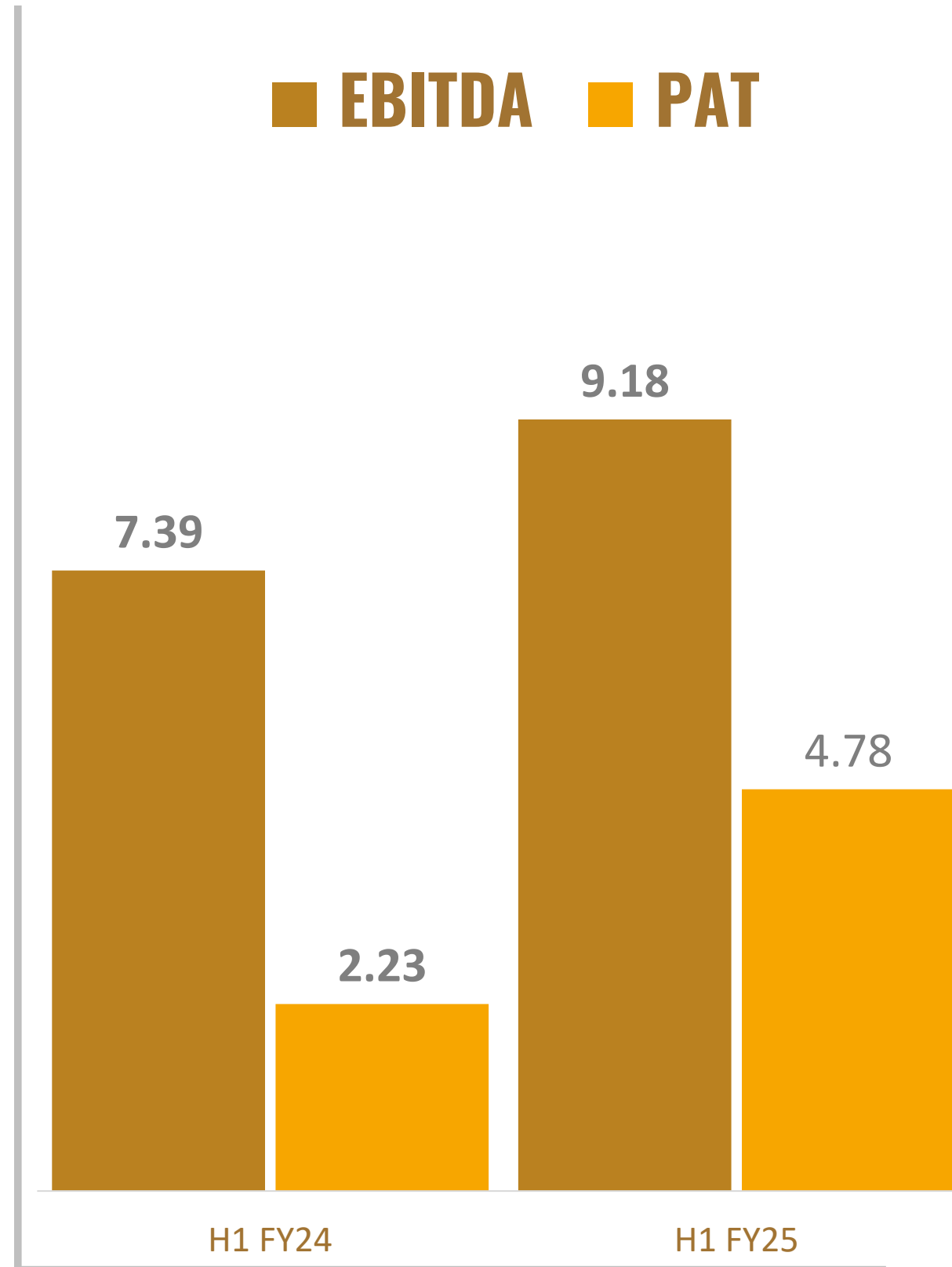

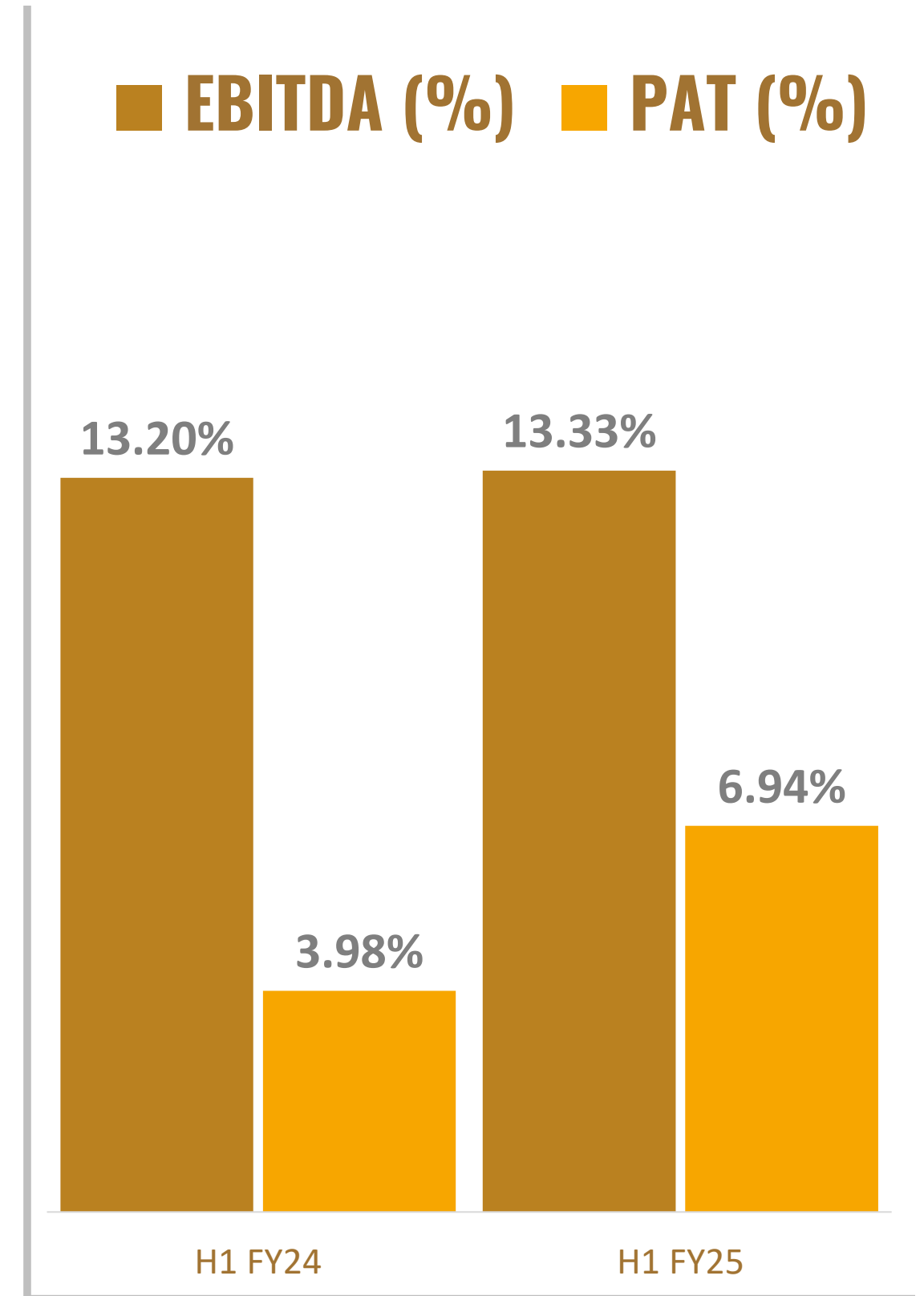

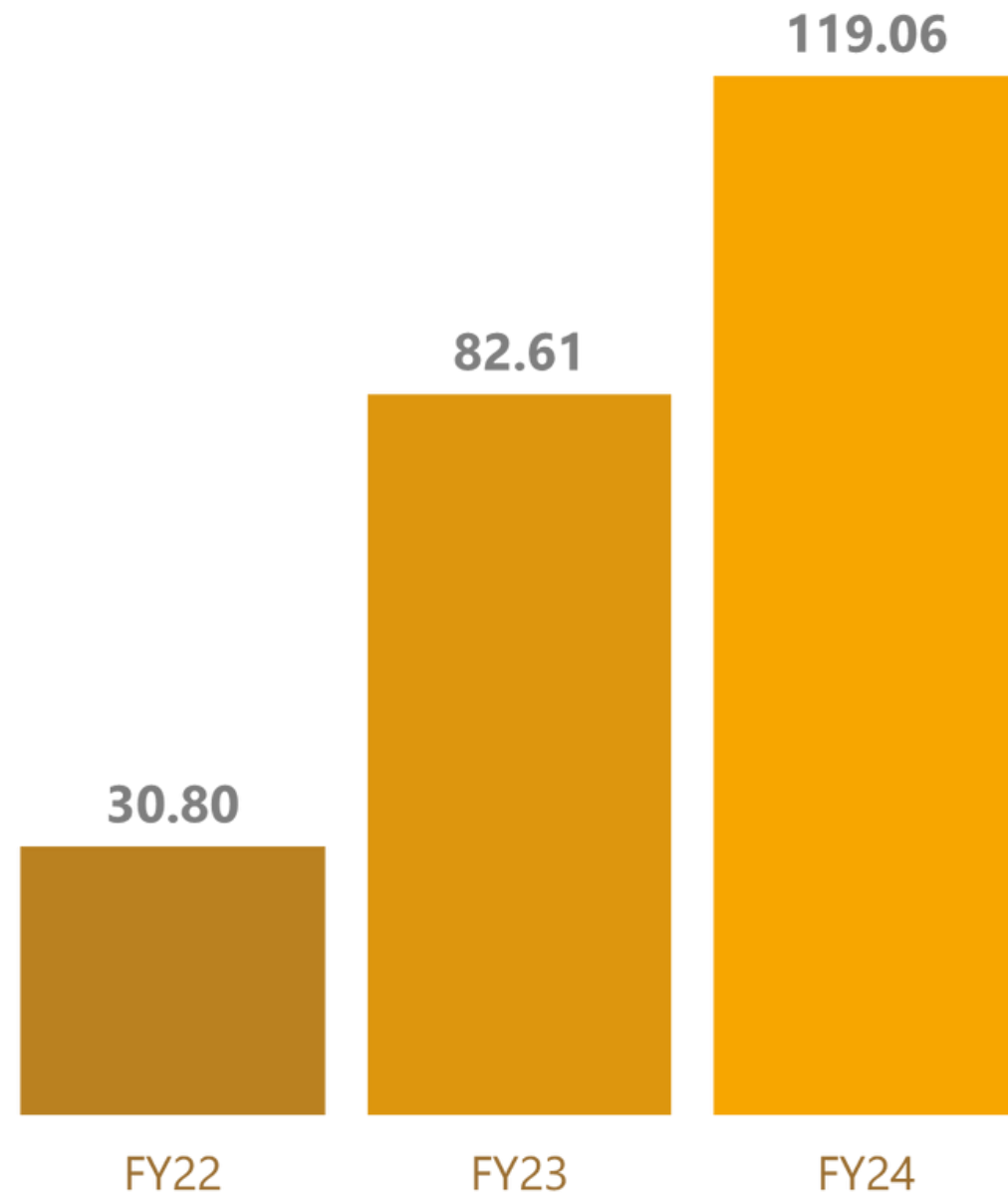

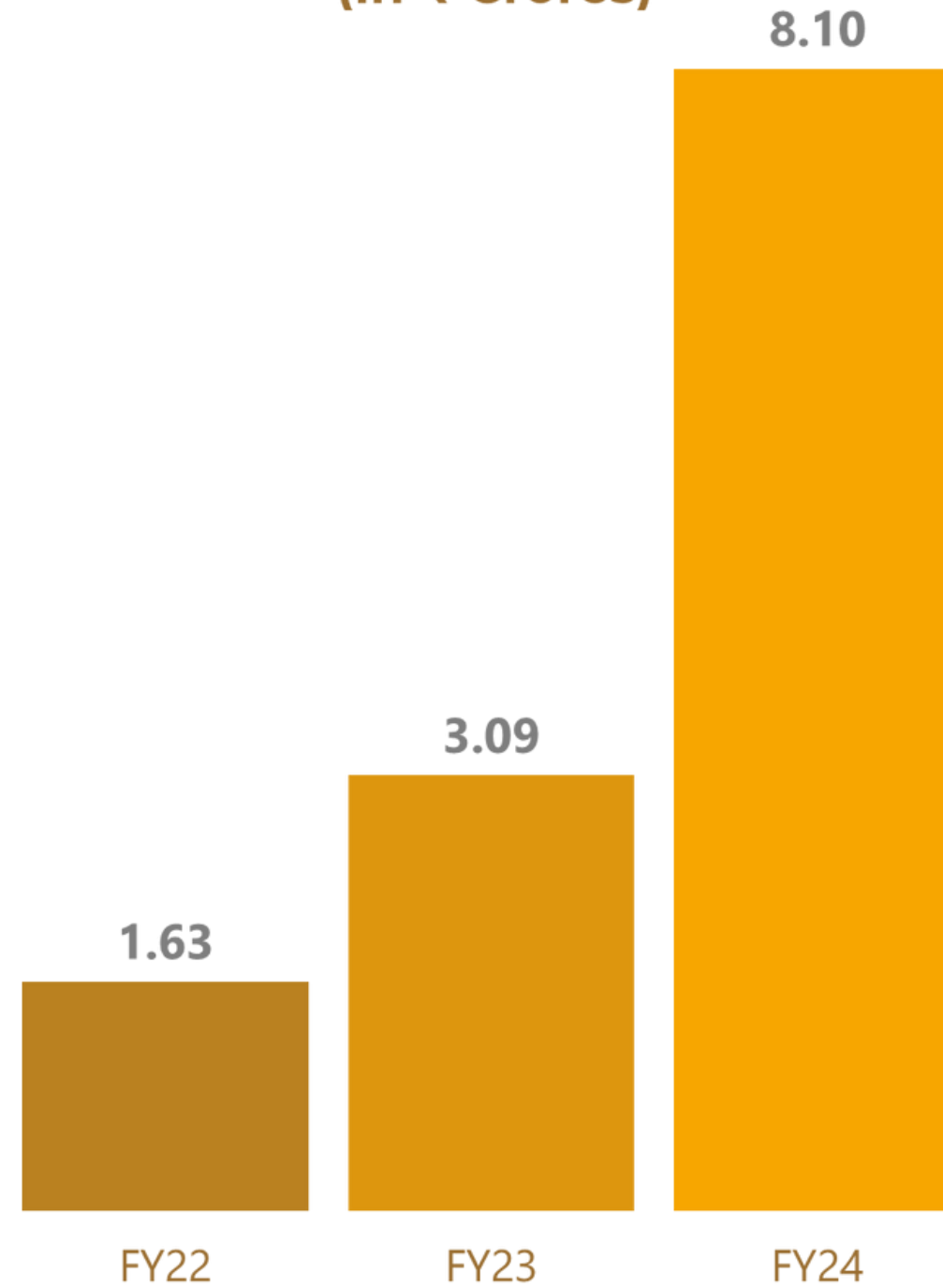

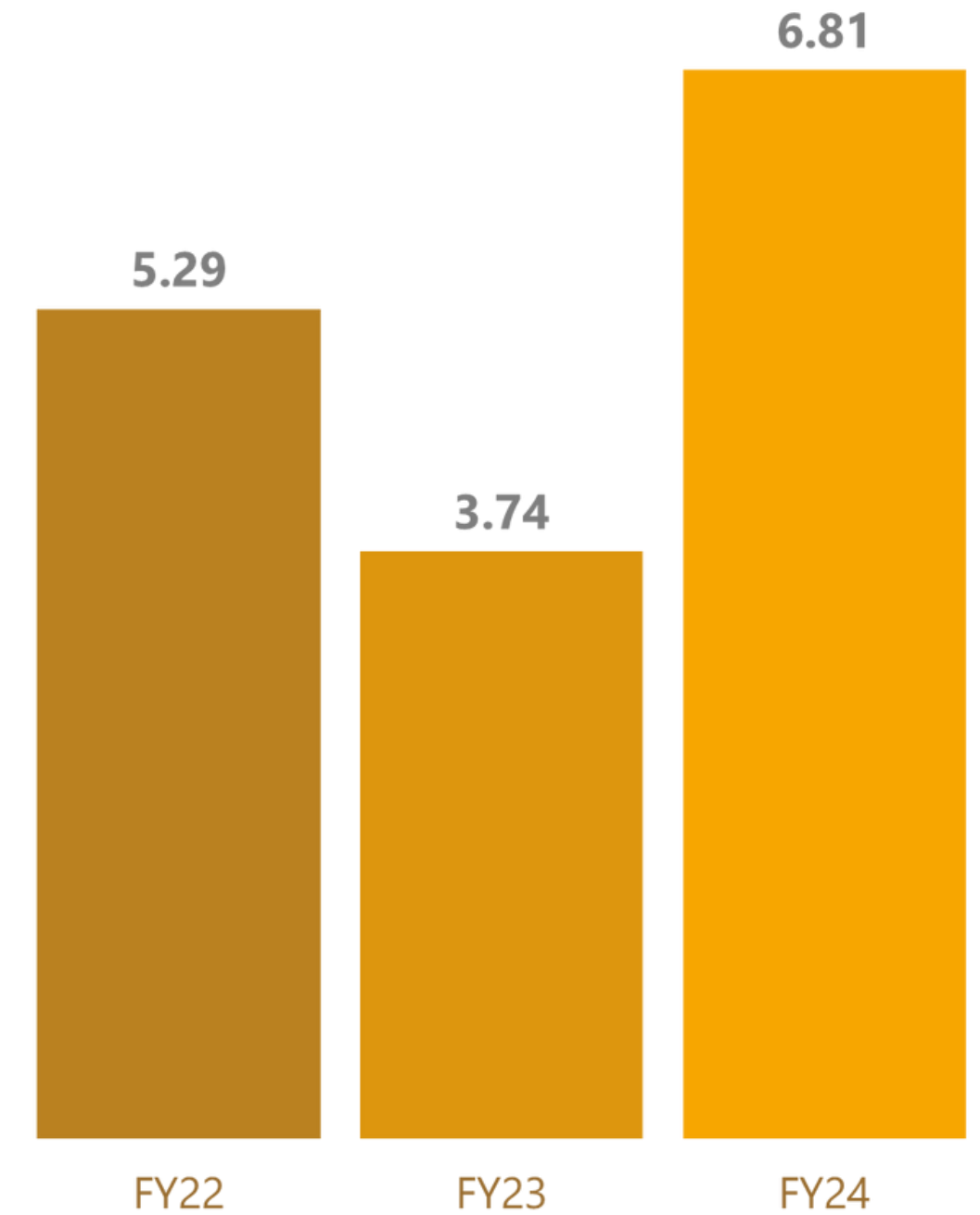
Net Profit

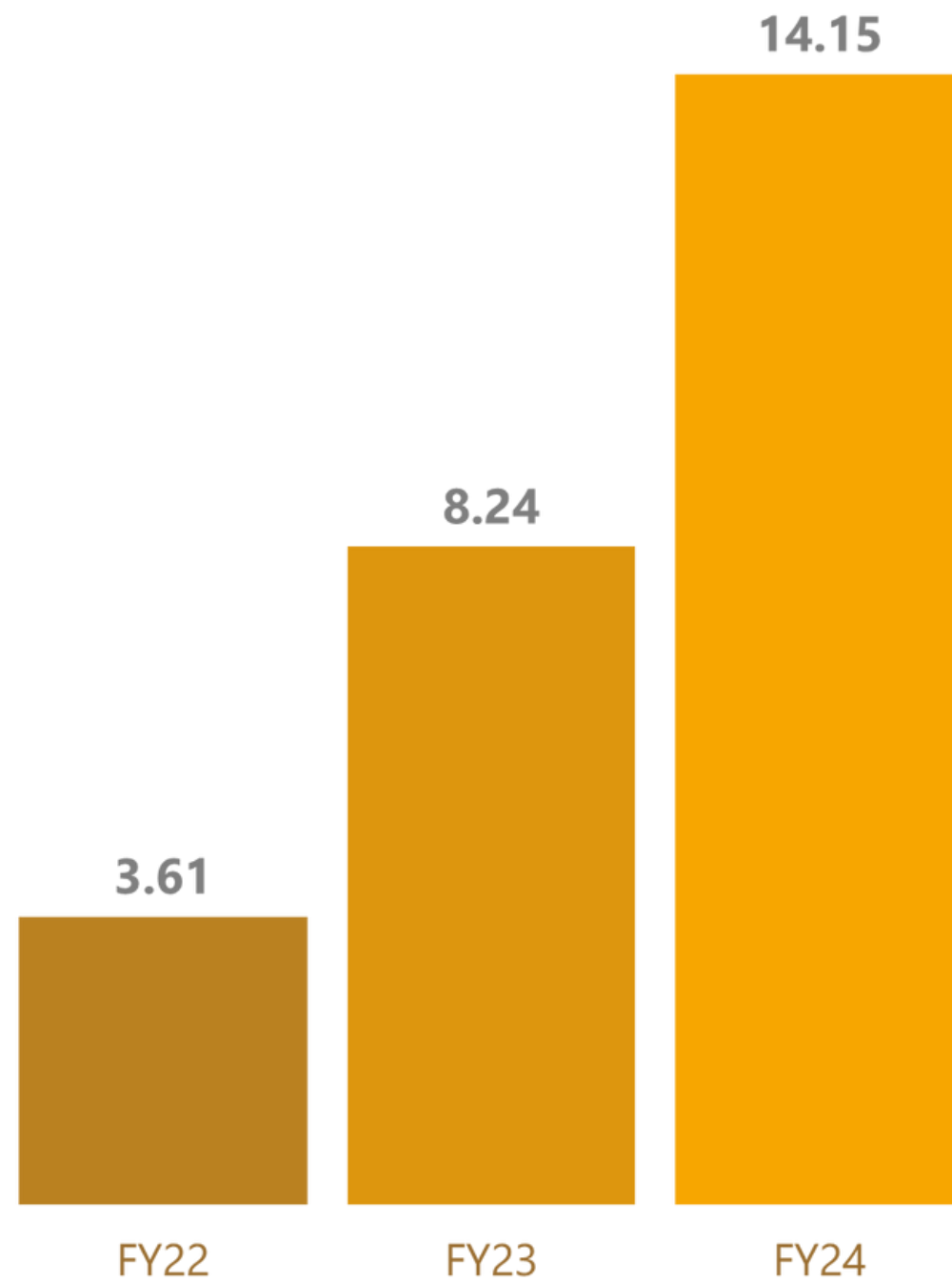

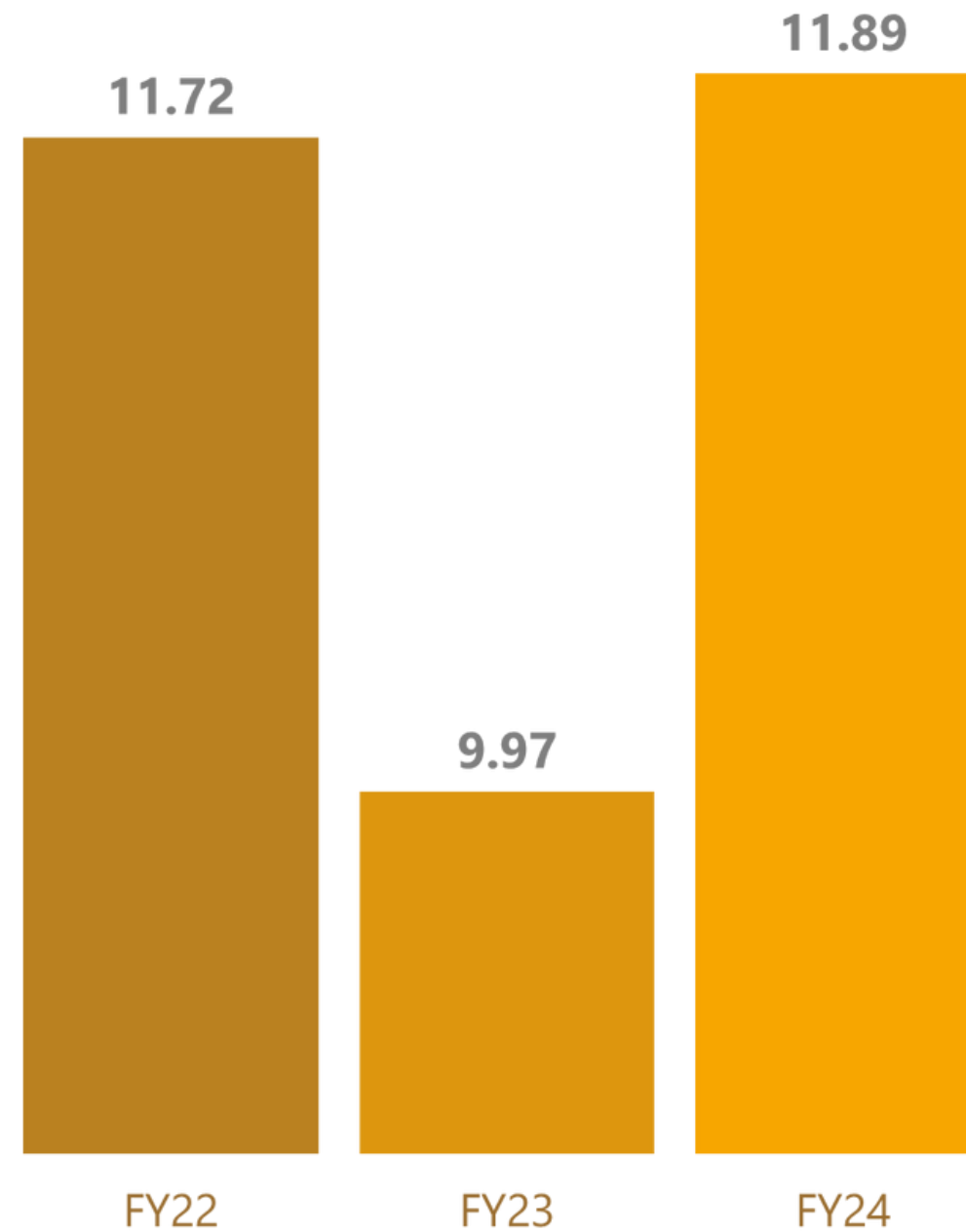

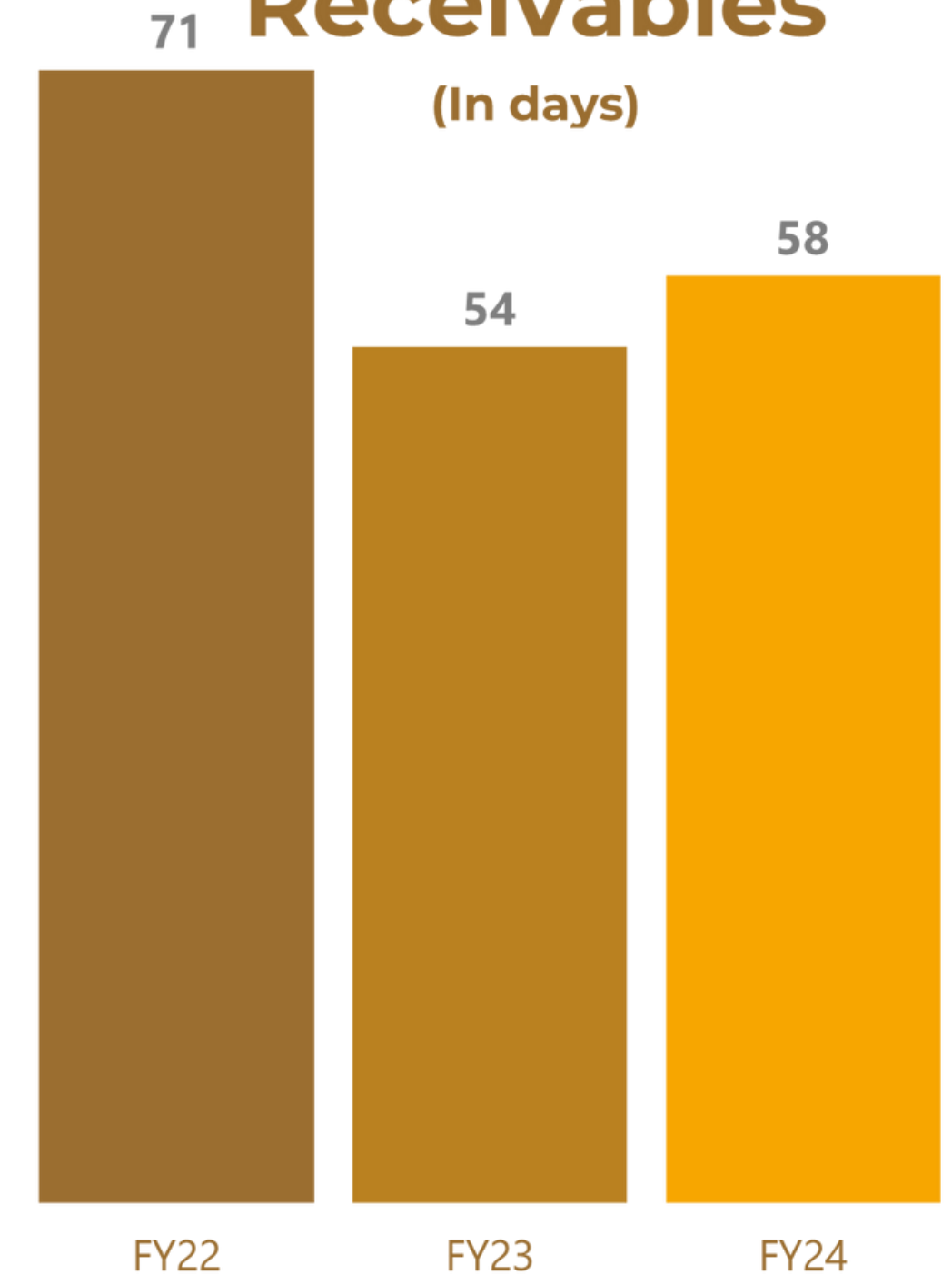
EBITDA (In ₹ Crores)



EBITDA Margin (In %)



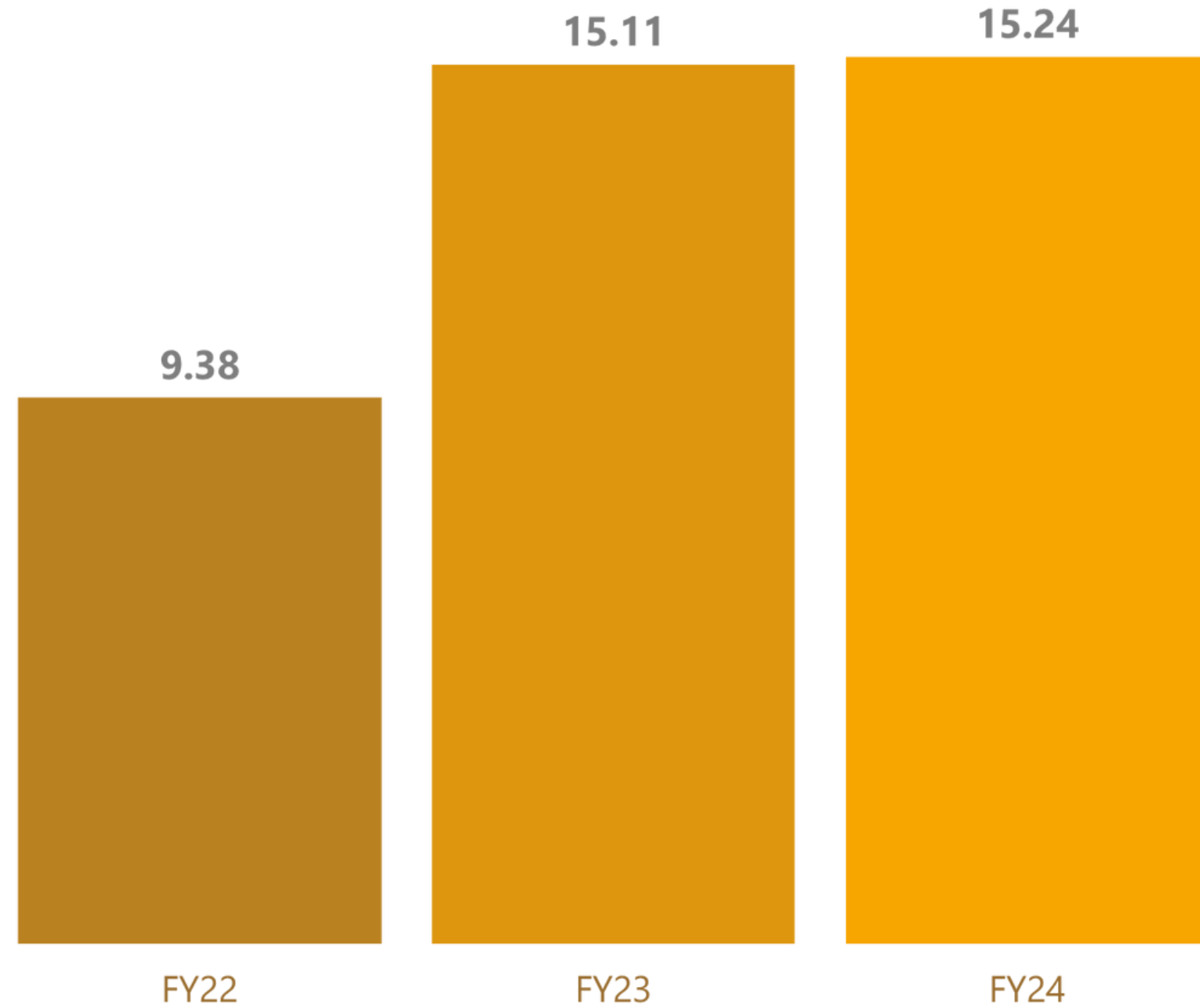

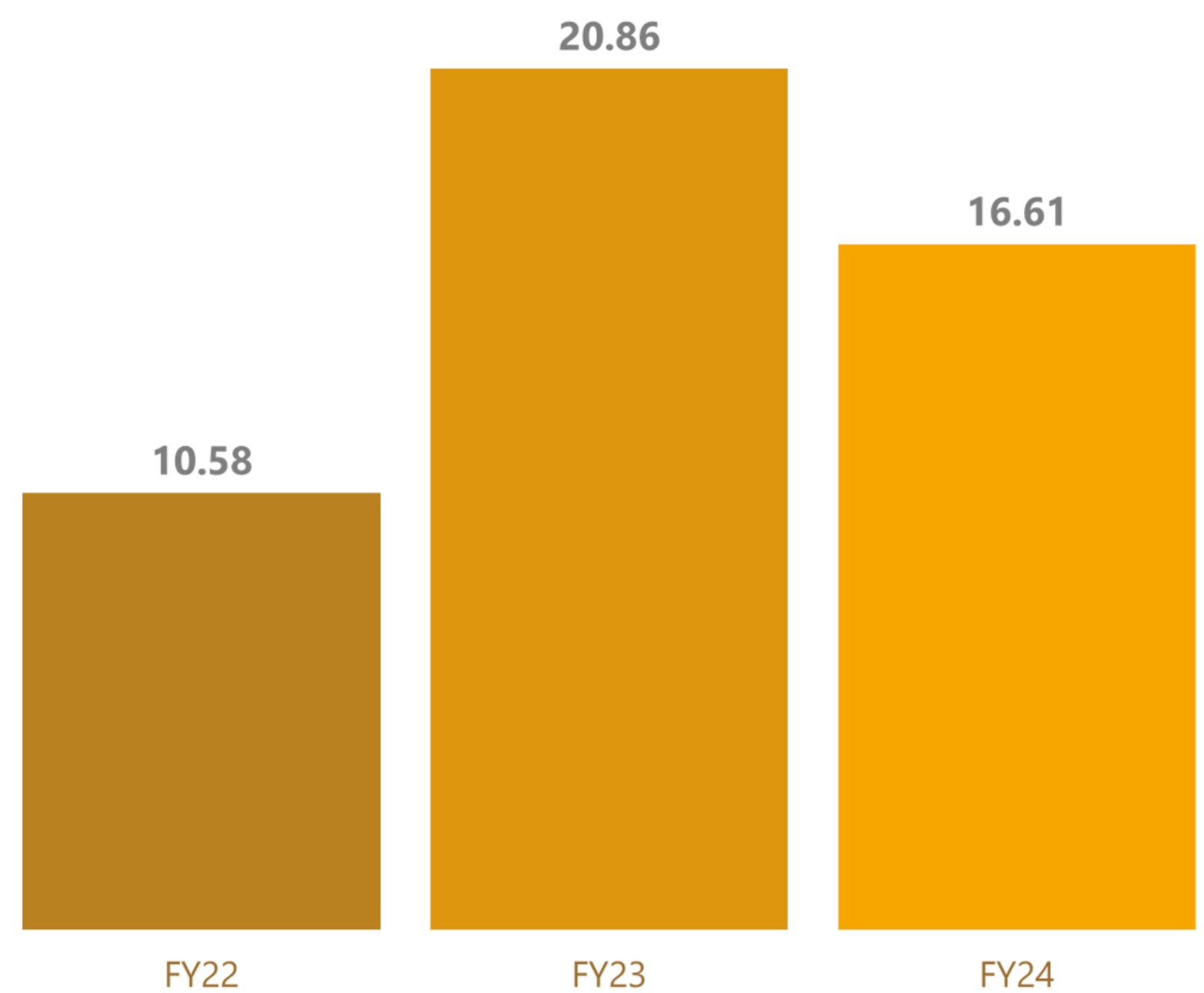

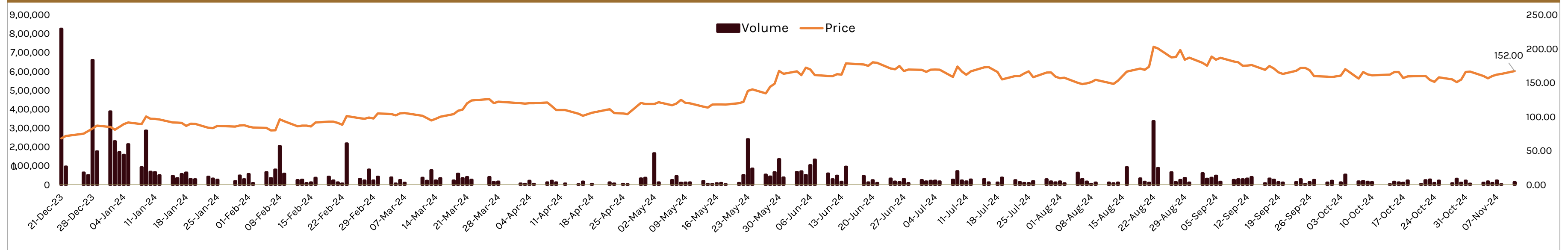
