**Sub: Request Letter for Reclassification from the "Promoter Group" category to "Public" category shareholders of Shree Rama Multi-Tech Limited ("SRMTL") as per as per Regulation 31A of SEBI (Listing obligations and Disclosure Requirements) Regulations, 2015**

Dear Sir,

We are writing this letter to inform you of our proposal for reclassification from "Promoter Group" of Shree Rama Multi-Tech Limited ("SRMTL") to "Public" category of shareholders in accordance with Regulation 31A of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("LODR Regulations")

As per the Regulation 2(1)(pp)(iii) of Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018, our Company is presently disclosed as Promoter Group of the SRMTL since Nirma Chemical Works Private Limited, the Promoter of SRMTL, is our holding Company. Since after disposal, NCWPL is now not holding any shares of our Company, we now don't fall under the category of Promoter Group under the above Regulation.

Under this scenario, we hereby apply under Regulation 31A of the LODR Regulation seeking reclassification of our Company from "Promoter Group" category to "Public" category shareholder of the SRMTL.

In support of the same, we hereby confirm in accordance with the above Regulation that:

- i. We do not hold more than ten percent of the total voting rights in SRMTL;
- ii. We do not exercise control over the affairs of SRMTL directly or indirectly;
- iii. We do not have any special rights with respect to SRMTL through formal or informal arrangements including through any shareholder agreements;
- iv. We are not being represented on the board of directors (including not having a nominee director) of SRMTL;
- v. We do not act as a key managerial personnel in SRMTL;
- vi. We are not 'wilful defaulter' as per the Reserve Bank of India Guidelines;
- vii. We are not fugitive economic offender.



Further we also confirm that:

- 1) We shall continue to comply with the conditions mentioned in sub-clauses (i), (ii) and (iii) clause (b) of Regulation 31A (3) of LODR Regulation at all times from the date of re-classification failing which, we shall be reclassified as promoter group of SRMTL.
  
- 2) We shall comply with the conditions mentioned in the sub-clauses (iv), (v) of clause (b) of Regulation 31A (3) of LODR Regulation for a period of not less than three years from the date of reclassification, failing which, we shall be reclassified as promoter group of SRMTL.

We request you to kindly consider and approve our request of reclassification as "Public" and arrange to undertake all such actions as may be necessary for completion of the reclassification.
