This is in reference to your application dated April 14, 2025, seeking no-objection for reclassification of one of the Promoter Group to public category namely 'Stericon Pharma Private Limited' under Regulation 31A of SEBI (LODR) Regulations, 2015.

In this regard, your attention is drawn towards the Regulation 31A (3)(b)(i) of SEBI (LODR) Regulations, 2015 which provides that:

"(b) The promoter(s) seeking re-classification and persons related to the promoter(s) seeking reclassification shall not:

(i) Together, hold more than ten percent of the total voting rights in the listed entity."

From the relationship provided by the listed entity of Stericon Pharma Private Limited with the remaining promoters of the listed entity wherein it is observed that the existing promoter entity named Nirma Chemical Works Private Limited ('Existing Promoter') is a holding Company of Stericon Pharma Private Limited ('Outgoing promoter group') and thus would qualify as a 'person related to the promoter seeking reclassification' in accordance with Regulation 31A of SEBI LODR Regulations, 2015 read with Regulation 2(1)(pp) of the SEBI ICDR Regulations, 2018 and the definitions of "holding company" and "subsidiary" under the Companies Act, 2013. Accordingly, the Existing Promoter is holding 56.53% of the listed entity and thus, in our view, the reclassification request submitted by the Outgoing Promoter is in non-compliance with Regulation 31A(3)(b)(i) of the SEBI LODR Regulations, 2015 that specifies that the promoter(s) seeking re-classification and persons related to the promoter(s) seeking re-classification shall not together, hold more than ten percent of the total voting rights in the listed entity and hence, the listed entity's application for reclassification of promoters group is rejected.


