Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 as amended ("SEBI Listing Regulations"), we wish to inform you that the Board of Directors of the Company at their meeting held today, i.e., Wednesday, September 3, 2025, inter alia considered and approved the following matters:

1. Resignation of Statutory Auditors

The Board noted the resignation of M/s. S V J K and Associates, Chartered Accountants, (FRN: 135182W), as Statutory Auditors of the Company with effect from September 3, 2025, for the reasons stated in their resignation letter. A copy of the resignation letter along with annexure, as received from M/s. S V J K and Associates, is enclosed herewith as **Annexure-A**.

The Board further noted that there are no material reasons for resignation other than those mentioned in their letter dated September 3, 2025.

2. Appointment of Statutory Auditors

Based on the recommendation of Audit Committee, the Board approved and recommended the appointment of M/s. Jain K S and Associates, Chartered Accountants, (FRN: 160810W), as the Statutory Auditors of the Company, for a term of 5 (five) consecutive years commencing from the FY 2025-26 until the FY 2029-30, subject to the approval of shareholders at the ensuing General Meeting.

3. Appointment of Secretarial Auditors

The Board, based on the recommendation of the Audit Committee, approved and recommended the appointment of M/s. Nirav Shah & Associates, Practicing Company Secretaries (COP No. 27102), as the Secretarial Auditors of the Company for a term of five (5) consecutive years commencing from FY 2025-26 until FY 2029-30, subject to the approval of shareholders at the ensuing General Meeting.

The Board has also decided to withdraw its earlier recommendation made at the meeting held on May 29, 2025, for the appointment of M/s. G R Shah & Associates, Practicing Company Secretaries, as Secretarial Auditors of the Company. Since their appointment was subject to shareholders' approval and not effective, the withdrawal does not amount to a resignation.
