1. An explanatory statement pursuant to the provisions of Section 102 read with 110 of the Act, setting out the material facts and the reasons in respect of the resolution as set out above is annexed hereto.
2. Pursuant to the provisions of Section 110 of the Act read with the Rules and the MCA Circulars, the Company has an option to seek the approval of the members through postal ballot by way of remote e-voting for the above-mentioned resolution, instead of getting the same passed at a general meeting. ## 5. Information to members regarding remote e-voting:

- a) Pursuant to the provisions of Section 110 and 108 of the Act read with the Rules, Regulation 44 of the Listing Regulations, MCA Circulars and SS-2, the Company has extended the remote e-voting facility to the members to cast their votes electronically. The Company has engaged the services of CDSL as the agency to provide remote e-voting facility. The members may cast their votes remotely, using remote e-voting only on the dates mentioned hereunder.
- b) The facility to exercise vote through remote e-voting will be available during the following period:

- 7) After entering these details appropriately, click on “SUBMIT” tab.
- 8) Shareholders holding shares in physical form will then directly reach the company selection screen. However, shareholders holding shares in demat form will now reach ‘Password Creation’ menu wherein they are required to mandatorily enter their login password in the new password field. Kindly note that this password is to be also used by the demat holders for voting for resolutions of any other company on which they are eligible to vote, provided that company opts for e-voting through CDSL platform. **EXPLANATORY STATEMENT PURSUANT TO SECTION 102 (1) READ WITH SECTION 110 OF THE COMPANIES ACT, 2013, REGULATION 44 OF SEBI (LISTING OBLIGATIONS AND DISCLOSURE REQUIREMENTS) REGULATIONS, 2015**

The following statement sets out the material facts and reasons relating to the resolution mentioned in the Postal Ballot Notice.

**Item no. 1: To approve material related party transaction(s) with Pristine Malwa Logistics Park Private Limited**

The Company requires dumpers, excavators, tankers, bulldozers, graders (hereinafter, collectively, referred to as the “**Commercial Equipment**”) for running its ongoing projects smoothly and improving its revenue streams. Based on its financial journey and history, the Company is exploring alternative financial solutions beyond bank loans for meeting the requirement of Commercial Equipment.

Pristine Malwa Logistics Park Private Limited (“**Pristine Malwa**”), being the intermediate holding company has agreed to give the Commercial Equipment to the Company on lease basis. In terms of Regulation 2(1) (zb) of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended (“**Listing Regulations**”), Pristine Malwa is the ‘related party’ of the Company.

Further, as per the Regulation 2(1)(zc) of the Listing Regulations, any transaction involving a transfer of resources, services or obligations between (i) a listed entity or any of its subsidiaries on one hand and a related party of the listed entity or any of its subsidiaries on the other hand; or (ii) a listed entity or any of its subsidiaries on one hand and any other person or entity on the other hand, the purpose and effect of which is to benefit any related party of the listed entity or any of its subsidiaries, regardless of whether a price is charged or not, is considered as ‘related party transaction’.

Furthermore, Regulation 23 of the Listing Regulations, *inter-alia*, states that all material related party transactions shall require prior approval of the members by means of an ordinary resolution, even if such transactions are in the ordinary course of business and at an arm’s length pricing. A transaction with a related party shall be considered material, if the transaction(s) to be entered into individually or taken together with the previous transactions during a financial year, exceeds Rs.1,000 crore or 10% of the annual consolidated turnover of the listed entity as per the last audited financial statements of the listed entity, whichever is lower.

In March 2025, Pristine Malwa leased 42 (forty-two) Commercial Equipment to the Company for a period of 5 years. The value of the said transaction was Rs.1.43 crore (exclusive of applicable taxes) during the financial year 2024-25, which is at present within the materiality thresholds as prescribed under the Listing Regulations (mentioned above).

With the increased requirement of the Commercial Equipment, the Company plans to take on lease additional 17 (seventeen) Commercial Equipment from Pristine Malwa in the financial 2025-26 for a period of 5 years.

The aggregate value of above-mentioned transactions with Pristine Malwa is now expected to exceed the 10% of the annual consolidated turnover of the Company as per the last audited financial statements of the Company, classifying it as a material related party transaction for the Company.

In compliance with the Listing Regulations, Companies Act, 2013 and other applicable laws/statutory provisions, if any, the audit committee, after its deliberation, had approved the said transaction(s) between the Company and Pristine Malwa. The transaction(s) are in the ordinary course of business and on an arm's length basis.
