**Subject: Outcome of the Board Meeting relating to Reclassification under Regulation 31A of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI Listing Regulations") from Promoter and Promoter Group category to Public category.**

Further to our intimation dated July 02, 2025, regarding receipt of requests from Promoter and Promoter Group of the Company, seeking reclassification as Public under Regulation 31A of SEBI Listing Regulations, we hereby inform that the said requests for reclassification were placed before the Board of Directors at its meeting held today i.e. on Friday, July 04, 2025.

The Board of Directors noted that Dr. Niren Chand Suchanti, Mr. Navin Chand Suchanti, Ms. Pramina Suchanti and Pressman Realty Private Limited, belonging to the category of "Promoter and Promoter Group" of the Company (details of their respective shareholding is given in Annexure A), vide request letters received on July 02, 2025 under Regulation 31A of SEBI Listing Regulations, requested the Company for reclassification to the "Public" category. The Company intimated the receipt of the said requests to the stock Exchanges immediately on July 02, 2025.

The Board noted that, in their respective requests, the Applicants have confirmed that:

- They do not, together hold more than ten percent of the total voting rights in the listed entity;
- They do not exercise control over the affairs of the listed entity directly or indirectly;
- They do not have any special rights with respect to the listed entity through formal or informal arrangements including through any shareholder agreements;
- They do not represent on the board of directors (including as a Nominee Director) of the listed entity;
- They are not a 'wilful defaulter' as per the Reserve Bank of India guidelines;
- They are not a fugitive economic offender.

The Board also noted that the Applicants have given an undertaking that they will comply with the conditions set out in Regulation 31A(3)(b) of the SEBI Listing Regulations. Pursuant to the provisions of Regulation 31A(3) of the SEBI Listing Regulations, the Board was informed that the said reclassification shall require approval of the Board and the stock exchanges viz. BSE Limited and National Stock Exchange of India Limited (collectively, the "Stock Exchanges").

On the basis of the above rationale and in accordance with the provisions of Regulation 31A of the SEBI Listing Regulation." the Board was of the view that the requests made by the Applicants for reclassification from the category of 'Promoter' or 'Promoter Group' to 'Public' category Shareholders, which shall be subject to the approvals of the Stock Exchanges, and/ or such other approval, as may be required, were in compliance with Regulation 31A of SEBI LODR and hence the Board approved the said requests.
