NEP to help discard 'slave mentality' regarding English: PM Modi



ADALAJ: PM Narendra Modi on Wednesday said the 5G telecom service would take the education system in the country to the next level as the latest technology will go beyond smart facilities, smart classrooms, and smart teachings.

He also asserted that the New Education Policy (NEP) will pull the country out of the "slave mentality" surrounding the English language. He was speaking after launching the Gujarat government's Mission Schools of Excellence initiative at Adalaj in Gandhinagar district. He pointed out that knowledge of English was considered as the mark of being intellectual even though the English language is just a medium of communication.

The Mission will help strengthen education infrastructure in Gujarat by setting up new classrooms, smart classrooms, computer labs and overall upgradation of the infrastructure of schools in the state.

"Recently-launched 5G service will go beyond smart facilities, smart classrooms, and smart teachings. It will take our education system to the next level," Modi said.

The Prime Minister also advocated the use of local languages to make sure that those uncomfortable with English are not left behind.

"Earlier, knowledge of the

English language was considered a criterion of being intellectual. In reality, the English language is just a medium of communication. This language barrier was a hindrance. Many young talents from villages could not become doctors and engineers because they were not well-versed in English," he said.

The PM said youngsters now have the option to pursue studies in other languages.

"We aim to ensure that children of poor parents

become doctors and engineers even if they are not educated in English (medium). We want to ensure that no one is left behind due to the lack of the English language," Modi said, adding the "New Education Policy of the Centre will pull the country out from this slave mentality surrounding the English language".

The prime minister said that Gujarat has experienced a drastic change in the education scenario during the last two decades.

Under the Mission Schools of Excellence, the state government will build 50,000 new classrooms and convert nearly 1 lakh existing classrooms of government-run schools into smart classrooms using 5G technology, the prime minister said. "Using this technology, a teacher can impart real-time education to several schools in villages through online mode. Now, the best education and content will reach everyone. Students of villages will be benefited the most because of this initiative," the PM said.

21st October is observed as Police Commemoration Day. It is a national holiday to pay tribute to the martyrs who have sacrificed their lives in the line of duty. It is also a day to express gratitude to the officers and the families of those who continue to serve and protect us every day. "The Wall of Valour" - 30 feet tall granite sculpture stands at a police memorial with the names of over 35,000 martyrs who sacrificed their lives in the line of duty and reminds them of their valour and glory. This is day is observed as Martyr's Day in all police forces of India.

Since Independence, 34,832 Police personnel have sacrificed their lives for safeguarding the integrity of the nation and providing security to people of this country. Since Independence, 23,000 Indian Army soldiers have made supreme sacrifice. If we deeply go to the reality, with the increasing rate of crimes, today, the shortage of manpower has an impact both on crime prevention and detection. With the increasing rate of crimes, shortage of



manpower will have an impact both on crime prevention and detection. Inspectors and SIS at the police station have little time to focus on all cases and investigation is usually confined to sensational cases or grave crimes. From problems relating to police organisation, infrastructure and environment to obsolete weaponry and intelligence gathering techniques to shortage of manpower to corruption, police force in the country is not in a good shape.

There are Police personnel who are also complaining of stress due to over working. Deployment of police for traffic regulation and accident prevention activities also takes a beating. There are occasions where most of the time Police personnel goes attending to day-to-day functions like VIP

security, public agitations etc. For every Indian VIP, there are three police personnel. There are as many as 47,557 cops protecting 14,842 VIPs across the country which comes to a ratio of three to one. The incidents of chain and bag snatching have also been reported frequently across the city. While residents and experts stress the need for increased patrolling, the question many ask is if there are enough policemen to do the job. The shortage of staff often leads to delay in investigation and filing of charge-sheet in cognizable offences. There should be no compromise in the deployment of men for vehicle checks, night patrolling and traffic regulation. Unlike the Assembly elections where Central para military forces

were roped in for security, the State Police have to manage the local body polls with the available strength. With no major recruitment done in recent times and thousands of police personnel retiring each year, the vacancies are set to increase, making it difficult for police to manage the election along with routine duties. The increasingly sedentary lifestyle of younger generations, the increased occurrence of obesity, and the relatively low fitness level of so many people have also led to a smaller group of potential police officer candidates. There is a huge manpower shortage in the police department. The police-population ratio, currently 192 policemen per lakh population, is less than

what is recommended by UN i.e. 222 policemen per lakh. There is now a serious requirement for the execution of the proposed system as the city population is growing and a stronger police force is needed to tackle crime and L & O situations. It is also reported that more and more police personnel were being diagnosed for hypertension, diabetes and stress-related ailments in the annual health screening camps. The situation is more or less the same in many stations in the city where police personnel are forced to put in extra hours. Therefore, the State Government should recruit personnel on a war footing. 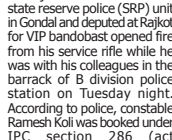

Phishing website of Adani Group club created



AHMEDABAD: Cybercrime police of Gandhinagar range on Tuesday registered a complaint against unknown persons for creating a phishing website, mimicking the website of a club run by the Adani Group. According to investigators, an employee of Adani Group named Ashish Mehta filed a complaint with police after some people approached them complaining about the fraud. An investigator said cybercrooks had created the website in August. A resident of Ahmedabad had approached the Belvedere Golf and Country Club saying he got a club membership from a website and wanted to stay there. When the group's employees checked, they found no such booking. The person then showed them the website on which he had booked a stay at the clubhouse and it was found that a phishing website had been created by cybercrooks. Investigators said the corporate group informed Google about the fraud and that phishing website was removed. The accused also posted notices on the website of Belvedere Golf and Country Club on the website with the title "The Belvedere Golf and Country Club", the FIR states. Police filed a complaint for breach of trust and cheating along with charges under the Information Technology Act. According to investigators, an employee of Adani Group named Ashish Mehta filed a complaint with police after some people approached them complaining about the fraud. An investigator said cybercrooks had created the website in August.

SRP jawan opens fire in barrack



RAJKOT: A constable with the state reserve police (SRP) unit in Gondal and deputated at Rajkot for VIP bandobast opened fire from his service rifle while he was with his colleagues in the barrack of B division police station on Tuesday night. According to police, constable Ramesh Koli was booked under IPC section 286 (act endangering human life using explosives). Additional forces from different districts were in the city for security purposes on Tuesday ahead of Prime Minister Narendra Modi's visit on Wednesday. A team of SRP from Gondal was part of the same security arrangement. They were given accommodation at B division police station and Kuvada road police station. About 25 jawans of SRP Gondal unit were then accommodated on the top floor of the B division police station. Koli was assigned duty to escort the team of Gordhan Zadafya on Tuesday morning. According to police, Koli suddenly fired one round into the ceiling of the barrack in which he was resting with others. "It is believed that Koli was tense because of some personal reasons. His colleagues snatched the rifle from Koli and removed the bullets before informing the police. Koli was issued the rifle and 20 rounds, and added police. Rout those insulting Gujarat with 'canards': Modi tears into AAP

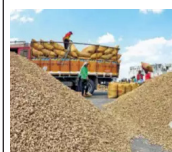

Groundnut crop estimated at 29 lakh tonnes: Shri Saurashtra Oil Mills Association



RAJKOT: Shri Saurashtra Oil Mills Association (SOMA), the apex body of oil millers in Gujarat has estimated the groundnut production this season to 29 lakh tonnes, four lakh tonnes less compared to last year. The estimates were released on Monday. The demand for groundnut has increased in the domestic market due to

drastically less harvest in southern states. According to SOMA, 22 lakh tonnes of crop is expected from 10 districts of Saurashtra and the rest from Kutch and north Gujarat districts. The average yield this year is 1,650 kg per hectare, which is said to be good compared to the previous years when the same was around 1,450 kg per hectare. SOMA estimates show that the highest production of 4.55 lakh tonnes is expected in Rajkot district followed by 4.24 lakh tonnes in Junagadh and 2.79 lakh tonnes in Devbhumi Dwarka district.

Incidentally, the Solvent Extractors' Association of India (SEAI) on Sunday estimated groundnut production in Gujarat to around 30 lakh tonnes in the current year. This year, the crop was damaged due to excessive rain in Gir-Somnath and Junagadh districts.
