The Chairman of the 02nd Extra-Ordinary General Meeting (EGM) of the Shareholders of Silgo Retail Limited held on Saturday, January 03, 2026 at 12:30 p.m. through Video Conferencing (VC)/ Other Audio Visual Means (OAVM)

Dear Sir,

1. I, Mr. Amritanshu Balani, Practicing Company Secretary, have been appointed as Scrutinizer by the Board of Directors of Silgo Retail Limited ("Company") for the purpose of scrutinizing remote e- voting process and e-voting by the members who had participated in the AGM through video conferencing but have not casted their votes through remote e-voting, in a fair and transparent manner and ascertaining the requisite majority for passing of resolutions as mentioned in notice dated December 12, 2025 convening 02nd Extra-Ordinary General Meeting.

My responsibility is only to the extent of making Scrutinizer's Report for ascertaining the votes cast in favor or against for respective resolutions based on the reports generated from the electronic voting system provided by Central Depository Services (India) Limited ("CDSL").
3. The Company had availed the services of remote e- voting and e-voting during the AGM from Central Depository Services (India) Limited ("CDSL"), the agency authorized under the rules.
4. The Shareholders holding equity shares as on the "cut- off date" i.e. December 26, 2025 were entitled to vote on the resolutions proposed in the Notice calling the 02nd Extra-Ordinary General Meeting of the Company. The remote e- voting commenced on December 31, 2025 (9.00 A.M) and concluded on January 02, 2026 (5.00 P.M).
5. The votes casted through remote e-voting and e-voting by the members at the EGM were unblocked on Saturday, January 03, 2026 and downloaded from the e-voting website of CDSL (<https://www.evotingindia.com>) after the conclusion of the e-voting at the EGM in the presence of two witnesses who are not in the employment of the Company.
