Dear Sir / Madam,

In continuation of Announcement dated 16.09.2025, our company have also been awarded Letter of Award (LOA) for design, Survey, Supply, Installation, Testing, commissioning, Operation & Maintenance for 25 years from COD of grid connected solar power plants through RESCO Mode, its associated 11 KV line to connect the plant with various 33/11 KV sub-stations and remote monitoring system (RMS) of solar power plants under PMKUSUM Component A Scheme of Jodhpur Vidyut Vitran Nigam Limited (JDVVNL) for 3 more sites.

The combined SPV Solar Power plant shall be 5.50 MW under PMKUSUM Component A Scheme from these LOAs, with the final levelized tariff shall be Rs. 3.040 per unit for all 3 sites.
