We wish to inform you that the Company is listed on the SME Platform of NSE. As the Company falls under the aforesaid exemption, the corporate governance provisions specified under Regulations 17, 17A, 18, 19, 20, 21, 22, 24, 24A, 25, 26, 26A, 27, clauses (b) to (i) and (t) of sub-regulation (2) of Regulation 46, and Paras C, D, and E of Schedule V of the SEBI Listing Regulations are not applicable.
