Dear Sirs,

Pursuant to Regulation 30 of the SEBI LODR and our letter dated March 30, 2024, this is to further inform you that the Company has executed "Master Restructuring Agreement (MRA)" with National Asset Reconstruction Company Ltd (NARCL) on 15th January 2025. NARCL represents 85.44% in value of the secured lenders as on 31st March 2024. We are in discussions with the remaining lenders representing 14.56% for restructuring/ settlement. The company has to pay sustainable debt of Rs.1250 crores over a period of 7 years to all the lenders as per the terms of the MRA. In addition, NARCL will get on a fully diluted basis, 15% new equity shares of the Company from the conversion of unsustainable debt and pledge of 11% shares from the Promoter Group.
